STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-SEVEN

AN ACT Relating to the Possession of Forbidden Implements for Hunting and Fishing.

Be it enacted by the People of the State of Maine, as follows:

Section twenty-five of chapter two hundred and nineteen

- 2 of the public laws of nineteen hundred seventeen, as amend-
- 3 ed by chapter one hundred ninety-six of the public laws of
- 4 nineteen hundred nineteen, is hereby amended by insert-
- 5 ing before the word "No" in the first line of said section
- 6 the words 'No person shall sell or purchase in this state
- 7 any jacklight or light fitted for use in the hunting of game
- 8 in the night time,' so that said section, as amended, shall
- 9 read as follows:

'No person shall sell or purchase in this state any jacklight

2 or light fitted for use in the hunting of game in the night 3 time. No person shall have in possession at any time when 4 he is upon the wild lands, waters or highways, or in the 5 woods or fields of the state, or in any camp, lodge, or place 6 of resort for hunters or fishermen, or in its immediate 7 vicinity, any jacklight or light fitted for use in the hunting 8 of game in the night time, or any swivel, pivot or set gun; o nor shall any person have in possession at any time any 10 spear, trawl or net (except such as are authorized for the II taking of suckers, eels, hornpouts and yellow perch, as pro-12 vided in section twenty-seven of this chapter) other than 13 a dip-net, in any camp, lodge or place of resort for hunters 14 or fishermen or in its immediate vicinity, or on any of the 15 lakes, rivers or streams of the state, or in their immediate 16 vicinity, in the inland territory of this state. Whoever vio-17 lates any provision of this section shall be subject to a fine 18 of one hundred dollars and costs for each offense and im-19 prisonment for sixty days, and when any such implements 20 or devices are found in possession in violation of any pro-21 vision of this section they are forfeit and contraband, and 22 shall be seized by any person authorized to enforce the 23 inland fish and game laws."
