STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND TWENTY-SEVEN

AN ACT to Authorize the State Board of Dental Examiners to Issue Their Certificate, to Practice Dentistry in Maine, to Horace B. Damon.

Whereas, Horace B. Damon, now of Oakland in the county of Kennebec and state of Maine, was engaged in the actual and continuous practice of dentistry, in the state of Maine of two years immediately prior to the time when the act of nineteen hundred thirteen, authorizing the appointment of a board of dental examiners took effect.

And whereas, said Horace B. Damon has practiced dentistry for the past sixteen years continuously, except during the period of his service in the late World War.

And whereas, said Horace B. Damon, by his service in said

World War and by reason of the illness and death of his father, was unable to attend a dental college and take a course of four years therein.

And whereas, he has continued the practice of dentistry, since his discharge from said service, in a successful manner.

And whereas, his ability to so practice is attested by the extensive clientele he now has in said Oakland and vicinity.

Now, in consideration of the fact, that his said service in defense of his country, and his father's illness, prevented him from becoming a legal practitioner, therefore,

Be it enacted by the People of the State of Maine, as follows:

Horace B. Damon, of Oakland, in the county of Kennebec, 2 and state of Maine, may, within ninety days after the time 3 when this act shall take effect, pay to the treasurer of said 4 board the sum of twenty dollars and file affidavit in satis- 5 factory proof that he was engaged in the actual and con- 6 tinuous practice of dentistry in the state of Maine for two 7 years immediately prior to the time when the act of nine- 8 teen hundred thirteen authorizing the appointment of a 9 board of dental examiners took effect, and thereupon said 10 board shall issue, to said Horace B. Damon, its certificate, 11 under seal, signed by its president and secretary, author- 12 izing him to practice dentistry in this state, and said cer- 13 tificate shall be recorded in the office of the supreme judicial 14 court for the county of Kennebec, and shall pay said clerk 15 fifty cents for recording the same, and in the absence of 16 the original certificate an attested copy of such record shall

17 be received as evidence in all courts within the state of the
18 right of said Horace B. Damon to practice dentistry within
19 the state.
