## STATE OF MAINE

---

IN THE YEAR OF OUR LORD ONE THOUSAND NINE  
HUNDRED AND TWENTY-SEVEN

---

AN ACT Relating to Hunting and Fishing Licenses.

---

Be it enacted by the People of the State of Maine, as follows.

Section two of chapter one hundred seventy-three of the  
2 public laws of nineteen hundred nineteen, as amended by  
3 chapter one hundred twenty-one of the public laws of nine-  
4 teen hundred twenty-three, is hereby amended by striking  
5 out of the words "twenty-five cents, ten cents" in the fifth  
6 and sixth lines of said section, and substituting therefor  
7 the words 'one dollar and fifteen cents, fifteen cents' so  
8 that said section as amended shall read as follows:

'Section 2, as amended: Any resident of this state may  
2 make written application to the clerk of the city, town or  
3 plantation in which such resident resides, and such city,

4 town or plantation clerk after having satisfied himself that  
5 the applicant is a bona fide resident of said city, town or  
6 plantation, and upon the payment by such applicant of a  
7 fee of one dollar and fifteen cents, fifteen cents of which  
8 shall be retained by said clerk as a recording fee, shall issue  
9 to such applicant a certificate in the form prescribed and  
10 upon blanks furnished by the commissioner of inland fish-  
11 eries and game, which certificate shall bear the name, age,  
12 occupation, place of residence, and an identifying descrip-  
13 tion of the holder of such certificate, and shall authorize  
14 the person so registered to hunt and kill such wild birds  
15 and wild animals as may be legally hunted, and to fish for,  
16 take, catch or kill fish in the inland waters of the state, in  
17 their respective open seasons and in the manner provided  
18 by law, on any lands or waters on which hunting or killing  
19 or fishing is not forbidden by law.

Such certificate shall authorize the hunting or killing of  
2 game and game birds, and the taking, catching and killing  
3 of fish in the inland waters of this state, only under such  
4 restrictions and for such purposes as are imposed or au-  
5 thorized by law.'
