STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND TWENTY-SEVEN

AN ACT Relating to the State Department of Health.

Be it enacted by the People of the State of Maine, as follows.

Section 1. Section eight of chapter one hundred ninety-
2 seven of the public laws of nineteen hundred seventeen, as
3 amended by chapter one hundred seventy-two of the public
4 laws of nineteen hundred nineteen, as amended by chapter
5 one hundred sixty-two of the public laws of nineteen hundred
6 twenty-one, as amended by chapter two hundred seventeen of
7 the public laws of nineteen hundred twenty-three, is hereby
8 further amended by striking out the word "fifty-three" and
9 inserting in place thereof the word 'sixty-five' so that said
10 section as amended shall read as follows:

'Sect. 8. The sum of sixty-five thousand dollars shall be

2 annually appropriated for the purposes set forth in sections
3 one to six inclusive, and section seven of this act.'

Sect. 2. Section two of chapter one hundred seventy-two
2 of the public laws of nineteen hundred nineteen, enacting
3 section sixteen as an additional section to chapter one hun-
4 dred ninety-seven of the public laws of nineteen hundred
5 and seventeen, as amended by chapter one hundred sixty-
6 two of the public laws of nineteen hundred and twenty-
7 one, as amended by chapter two hundred seventeen of the
8 public laws of nineteen hundred twenty-three, is hereby
9 further amended by striking out the word "thirty-eight" in
10 the second line thereof and inserting in place thereof the
11 word 'forty-six,' so that said section sixteen as amended
12 shall read as follows:

'Sect. 16. The sum of forty-six thousand dollars shall be
2 appropriated annually to the state department of health
3 for the purpose of carrying out the provisions of sections
4 six, ten, eleven, twelve, thirteen and fourteen.'

Sect. 3. Chapter nineteen of the revised statutes, as
2 amended by chapter three hundred one of the public laws
3 of nineteen hundred seventeen, and as amended by chapter
4 two hundred seventeen of the public laws of nineteen hun-
5 dred twenty-three, is hereby further amended by striking
6 out the word "fourteen" in the third line of section one
7 hundred thirty-one thereof and inserting in place thereof
8 the word 'eighteen,' so that said section as amended shall
9 read as follows:

'Sect. 131. For the purpose of enabling the state board
2 of health to carry out the provisions of this act there is
3 hereby appropriated the sum of eighteen thousand dollars.'
