STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-SEVEN

AN ACT to Incorporate Somerset Woods Trustees.

Be it enacted by the People of the State of Maine, as follows: Section I. Louise H. Coburn, George Otis Smith, William
Philbrick, Francis H. Friend, Gertrude S. Weston and
3 Ernest C. Butler all of Skowhegan in the county of Som4 erset and state of Maine and Joseph C. Smith of Water5 ville in the county of Kennebec and state of Maine, their
6 associates, successors and assigns, be and they hereby are
7 constituted a body, politic and corporate, by the name of
8 Somerset Woods Trustees, with power to fill vacancies in
9 their numbers and to increase their number by election of

11 twelve in all for the purpose of acquiring, holding, manag-12 ing, arranging, maintaining and where practicable, opening 13 to the public under suitable regulations to be established 14 by said corporation, such tract or tracts of land as said 15 corporation may be able to acquire within the county of 16 Somerset, with the right and power to hold such personal 17 property as may be necessary or convenient in the managing 18 of said tract or tracts of land acquired and held as afore-19 said, with the powers and privileges and subject to the cuties 20 set forth in chapter fifty-one of the revised statutes of the 21 state of Maine, and in such other general laws as now are 22 or hereafter may be in force relating to such corporations, 23 providing, however, that said corporation shall have no capi-24 tal stock nor shall it pay any compensation to any of its 25 members in lieu of salary or wages.

Sect. 2. Said corporation may acquire and hold by gift, 2 grant, devise or purchase, real estate, such as it may deem 3 worthy of preservation for the enjoyment of the public 4 directly or indirectly, but not exceeding two hundred thou-5 sand dollars in value, with the right to sell and convey any 6 part of said real estate, if in the changing conditions it 7 seems advisable to sell any part thereof and hold by gift, 8 grant, devise or purchase, such other property, both real 9 and personal, as may be necessary or proper to support or 10 promote the objects of the corporation, but not exceeding 11 in the aggregate the further amount of two hundred thou-12 sand. Sect. 3. All property held by said corporation shall be 2 exempt from taxation.

Sect. 4. Said corporation shall never make any dividend 2 or division of or from its property or income among its 3 members, but the net income and proceeds from any part 4 of said property shall be expended for public benefits, not 5 supported by taxation, in the town where said land from 6 which said income or proceeds shall be derived is located.
