# IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-SEVEN

AN ACT to Ratify, Affirm and Make Valid, Certains Doings of the City Council of the City of Bath.

Be it enacted by the People of the State of Maine, as follows:

That the following acts and doings of the city council of

the city of Bath, in the county of Sagadahoc, are hereby

ratified, affirmed and made valid:

  - Sect. 11. This act shall take effect when approved.
