STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-NINE

AN ACT Relating to the Annual Payments to the Kennebec Law Library.

Be it enacted by the People of the State of Maine, as follows:

Section eight of chapter thirteen of the revised statutes,

- 2 as amended by chapter thirty of the public laws of nineteen
- 3 hundred and twenty-one, is hereby further amended by
- 4 striking out the words "county of Lincoln" in the second
- 5 line and inserting in place thereof the words 'counties of
- 6 Kennebec and Lincoln' and by inserting the words 'The
- 7 treasurer of the county of Kennebec shall annually pay
- 8 to the treasurer of the law library association of his county

9 the sum of eight hundred dollars' after the word "dollars" 10 in the seventh line, so that said section as amended shall 11 read as follows:

'Sect. 8. The treasurer of each county, except the counties 2 of Kennebec and Lincoln, shall annually pay to the treas-3 urer of the law library association of his county, for the 4 uses and benefits of the county law library, the sum of five 5 hundred dollars. The treasurer of the county of Lincoln 6 shall annually pay to the treasurer of the law library asso-7 ciation of his county, the sum of two hundred and fifty 8 dollars. The treasurer of the county of Kennebec shall g annually pay to the treasurer of the law library association 10 of his county the sum of eight hundred dollars. The II treasurer of Aroostook county shall pay annually to the 12 law library association of said county the sum of five hun-13 dred dollars, in addition to the five hundred dollars above 14 mentioned, and at least five hundred dollars shall be ex-15 pended annually by the library association of said county 16 for books for the library at the court house at Caribou in 17 said county. The treasurer of each county shall also pay 18 to the treasurer of the law library association of his county 19 all money received from persons admitted as attorneys in 20 the supreme judicial court upon motion, without a certifi-21 cate from the board of examiners of applicants for admis-22 sion to the bar.'
