STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-NINE

AN ACT to Provide Pensions for the Regular Policemen of the City of Westbrook.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Section twenty of the charter of the city of

- 2 Westbrook is hereby amended by the addition of the fol-
- 3 lowing paragraphs after the word service.

'Retirement pensions for the regular policemen provided

- 2 for, conditions. The regular policemen may be retired up-
- 3 on pension of half pay drawn by the person at the time of
- 4 retirement, who have been honorably discharged from the
- 5 police department by reason of:

'First: Having served in the capacity of regular policemen 2 for not less than twenty-five years, or

'Second: Having served in the capacity of regular police-2 men in said police department not less than twenty years 3 and having reached the age of sixty-five years, or

'Third: Having been permanently disabled in the perform-2 ance of duty.

'Widows, children and dependents of regular policemen, 2 provisions for. It shall be the duty of the city council of 3 the city of Westbrook to provide for payment to the widow 4 of any aforesaid member of its police department, who has 5 lost his life in the performance of his duty, an annuity of 6 not more than twenty-five dollars per month, so long as she 7 remains a widow and in need of such annuity. If any such 8 regular policeman who has lost his life in the performance 9 of his duty leaves no widow, such annuity shall be paid to 10 the minor child or children, or other person or persons de-11 pendent upon such regular policeman, for such period as 12 the city council shall determine.'

- Sect. 2. Inconsistent acts repealed. All acts and parts of 2 acts inconsistent herewith are hereby repealed.
- Sect. 3. This act shall take effect and be in full force, 2 when approved by a majority of the votes cast by those 3 qualified to vote in municipal elections in said city, voting 4 at the first annual election to be held on the ninth day of 5 December, in the year of our Lord, one thousand nine hun-6 dred and twenty-nine.

The city clerk shall reduce the subject matter of this act 2 to the following question and cause same to be printed on 3 the official election ballot: "Shall the act relating to the 4 retirement of regular policemen, upon half pay, be adopted?" and the voters shall indicate their preference by a 6 cross within a square upon their ballots, said ballots to contain squares for answer of said question, marked "Yes" and 8 "No" respectively.
