### STATE OF MAINE

# IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-NINE

AN ACT to Establish the Winthrop and Wayne Game Sanctuary in the Towns of Winthrop and Wayne.

Be it enacted by the People of the State of Maine, as follows:

Section 1. No person shall, except as herein provided, at
2 any time, hunt, pursue, shoot at or kill any wild animal or
3 any game or wild bird within the following described ter4 ritory situated in the towns of Winthrop and Wayne, in
5 the county of Kennebec: Beginning at the state aid road,
6 numbered one hundred thirty-three at its intersection with
7 a cross road running southerly, which connects with the
8 Fellows Hill road, so-called; thence running westerly, one

9 and six-tenths mile to the John S. Raymond road, so-called; 10 thence running southerly, one and two-tenths mile to the 11 road leading from Monmouth over Fellows Hill to Win-12 throp village; thence running easterly, six-tenths of a mile 13 to the bridge between Berry and Dexter ponds; thence 14 running northeasterly, seven-tenths of a mile to the cross 15 road first herein mentioned; thence running northerly by 16 said cross road, five-tenths of a mile to the point of be-17 ginning. The territory herein above described shall be 18 known, and in any proceedings under this act may be de-19 signated as the Winthrop and Wayne Game Sanctuary.

- Sect. 2. It shall also be unlawful for any person to have 2 in possession at any time any wild bird or wild animal taken 3 in violation of any provision of this act.
- Sect. 3. The provisions of this act shall not prohibit any 2 person residing within the limits of the above described 3 sanctuary from shooting at or destroying any wild bird or 4 any wild animal when found destroying his property, nor 5 shall it be construed to prohibit the trapping of fur-bearing 6 animals within the above described sanctuary in accordance 7 with the general laws of the state.
- Sect. 4. Whoever violates any provision of this act shall 2 be subject to a penalty of not less than ten nor more than 3 three hundred dollars and costs for each offense or im-4 prisonment for sixty days, or both said fine and imprison-5 ment.
  - Sect. 5. The commissioner of inland fisheries and game

- 2 is empowered to enlarge the territory of this sanctuary upon
- 3 the written consent of the owners of the additional land to
- 4 be included.
