IN THE YEAR OF OUR LORD ONE THOUSAND NINE  
HUNDRED AND TWENTY-NINE

AN ACT Relating to the Relicensing and Registration of  
Undertakers.

---

Be it enacted by the People of the State of Maine, as follows:

Sections thirty and thirty-one of chapter one hundred for-  
2 ty-one, of the public laws of nineteen hundred twenty-seven,  
3 amending chapter nineteen of the revised statutes, are here-  
4 by amended by striking out both of said sections and in-  
5 serting in place thereof the following:

'Sect. 30. *Fees, expiration and renewal of licenses and*  
2 *certificates of registration.* The fee for examination under  
3 section twenty-seven shall be five dollars, and all licenses  
4 and certificates of registration which have been, or may be

5 issued to undertakers and embalmers by the board of ex-  
6 aminers, shall expire on the thirty-first day of December,  
7 annually, provided that the licenses and certificates of reg-  
8 istration hereafter issued, shall be valid and shall not ex-  
9 pire until the last day of the following year. Any persons  
10 holding an embalmer's license or certificate of registration,  
11 issued under the provisions of this or any other law, may  
12 have the same renewed by making and filing with the sec-  
13 retary of said board of examiners an application therefor  
14 within thirty days preceding the expiration of his, or her,  
15 license or certificate of registration, upon blanks prescribed  
16 by said board, and upon the payment of a renewal fee of  
17 five dollars, provided, however, that any person neglecting  
18 or failing to have his, or her, license or certificate of reg-  
19 istration, renewed as above, may have the same renewed  
20 by making application therefor within thirty days after the  
21 date of such expiration, and upon the payment of ten dol-  
22 lars, revival and renewal fee.'

'Sect. 31. *Fund and purposes thereof.* The money thus  
2 received shall constitute a permanent fund for carrying on  
3 the work of the board and the compensation of its mem-  
4 bers, and for such expenses as may be necessarily incurred  
5 from time to time by said board on account of investiga-  
6 tions which said board may be required to make by reason  
7 of this act; for the proper expenses of a delegate, or dele-  
8 gates, who may at any time be sent by said board to the  
9 National Conference of Embalming Examiners, and for

10 expenses incurred for lectures, on suitable subjects pertain-  
11 ing to the profession of undertaking and embalming, said  
12 board being hereby required to, at least, once a year pro-  
13 cure such a lecture to be given for the benefit of the mem-  
14 bers of the undertaking and embalming profession of this  
15 state, provided always, that none of the expenses designated  
16 hereunder shall reduce the fund hereby created under the  
17 sum of one thousand dollars.'
