STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-NINE

AN ACT Relating to the Property of Extinct or Disbanded Baptist or Free Baptist Churches, Parishes or Societies.

Be it enacted by the People of the State of Maine, as follows:

Section 1. The United Baptist Convention of Maine, a
2 corporation duly organized and existing under the laws of
3 the state of Maine, shall be and become vested with the
4 property and effects of any extinct or disbanded Baptist or
5 Free Baptist church, parish or society within this state in
6 trust to apply the same to paying the debts, if any, of such
7 extinct or disbanded church, parish or society and to use
8 any surplus for the purposes and objects of said The United

9 Baptist Convention of Maine, and may sell and convert such 10 property and effects into money; provided, however, that 11 in the sale and disposition of property so devolving on said 12 The United Baptist Convention of Maine said society shall 13 be deemed in respect to the right and power of possession, 14 control, disposal and conveyance, the legal successor of 15 such extinct or disbanded Baptist or Free Baptist Church, 16 parish or society; and in the case of sale of such property 17 said The United Baptist Convention of Maine shall apply 18 to the supreme judicial court in equity within the county 19 where such property is situated for a judicial decree au-20 thorizing the sale thereof, and after such notice of said 21 application as the court may direct, such decree shall be 22 authority for making such sale.

Sect. 2. The United Baptist Convention of Maine, in or2 der to determine when any such Baptist or Free Baptist
3 church, parish or society is extinct or disbanded, shall call
4 a council of the local association of Baptist or Free Bap5 tist churches in which said church, parish or society is sit6 uated, and the finding of such council, together with the
7 decree of the court, shall be its authority for proceeding
8 to make such sale. Before the sale of any property as here9 inabove provided, notice of said sale shall be published at
10 least two weeks before the date of sale in a paper of wide
11 circulation in the vicinity of the property formerly used
12 by such extinct or disbanded church, parish or society; and
13 the decree of the court shall be recorded in the registry of

14 deeds for the county or counties in which said property is15 situated.
