## STATE OF MAINE

# IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-NINE

AN ACT to Set Off Certain Land from the Town of Hudson to be Annexed to the City of Old Town.

Be it enacted by the People of the State of Maine, as follows: Section I. All that part of the town of Hudson in Penob-2 scot county which is bounded and described as follows:
Beginning at a stone monument standing on the easterly
4 shore of Pushaw pond and in the south line of said Hudson;
5 thence south eighty-three degrees, fifty minutes east of said
6 south line of Hudson eighty-six rods twenty-one links from
7 said pond to a stone monument marking the southeast corn-8 er of said town of Hudson; thence northerly on the east

9 line of Hudson two hundred two rods to the outlet of 10 Pushaw pond; thence westerly along the southerly shore of 11 said outlet to Pushaw pond; thence westerly, southerly and 12 southeasterly along easterly shore of Pushaw pond to the 13 bound begun at, containing two hundred acres more or less, 14 together with the inhabitants thereof, is hereby set off from 15 the town of Hudson and annexed to the city of Old Town, 16 and said city of Old Town is hereby vested with all powers 17 and privileges and subject to all the duties and obligations . 18 attending the annexation of the above described land.

Sect. 2. The several inhabitants and all resident and non-2 resident owners of the land hereinabove described shall be 3 holden to pay all taxes which have been legally assessed 4 upon them by the town of Hudson for the year nineteen 5 hundred and twenty-eight, the collector of taxes for the 6 town of Hudson is hereby authorized and required to col-7 lect and pay all taxes to him committed for the year nine-8 teen hundred and twenty-eight according to his respective 9 warrants. This act so far as it relates to the setting off of 10 the above described land shall not take effect unless accepted II and approved by a majority vote of the legal voters within 12 said town of Hudson at the annual town meeting to be 13 called for the municipal year nineteen hundred and twenty-14 nine to nineteen hundred and thirty. The town clerk shall 15 reduce the subject of this act to the following question: 16 "Shall the Act to set off the following described land situate 17 in the town of Hudson, to the city of Old Town, to wit, all

18 that part of the town of Hudson in Penobscot county which 19 is bounded and described as follows: Beginning at a stone 20 monument standing on the easterly shore of Pushaw pond 21 and in the south line of said Hudson; thence south eighty-22 three degrees, fifty minutes east of said south line of Hud-23 son eighty-six rods twenty-one links from said pond to a 24 stone monument marking the southeast corner of said town 25 of Hudson; thence northerly on the east line of Hudson 26 two hundred two rods to the outlet of Pushaw pond; thence 27 westerly along the southerly shore of said outlet to Pushaw 28 pond; thence westerly, southerly and southeasterly along 29 easterly shore of Pushaw pond to the bound begun at, con-30 taining two hundred acres more or less, be accepted," And 31 the voters shall indicate by an X placed against the words 32 "Yes" or "No." The result shall be declared by the select-33 men and due certificate thereof filed by the town clerk with 34 the secretary of state.

Sect. 3. Whereas for the purposes of obtaining popular 2 approval of this act by the legally qualified voters of the 3 town of Hudson at the annual town meeting of the inhabi-4 tants of the said town of Hudson to be holden the eleventh 5 day of March, A. D. nineteen hundred and twenty-nine.

Whereas, for the purpose of enabling the assessors of the 2 city of Old Town to effect their assessment as of April one, 3 nineteen hundred and twenty-nine in the event that this act 4 is approved by the legally qualified voters of the town of 5 Hudson, and

Whereas, in the opinion of the legislature, these facts 2 render the immediate passage of this act necessary for the 3 proper performance of local municipal duties relative to 4 the setting off of the said land, by the town of Hudson and 5 the annexation of the said land by the city of Old Town 6 and constitutes an emergency within the meaning of the 7 constitution, now therefore,

Sect. 4. In view of the emergency recited in section three 2 hereof, this act shall take effect when approved.
