STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-NINE

AN ACT Relating to the Incorporation of a Council of the Boy Scouts of America.

Be it enacted by the People of the State of Maine, as follows:

Section one of chapter sixty-two of the revised statutes,

- 2 as amended by chapter forty-eight of the public laws of
- 3 nineteen hundred and nineteen and by chapter one hundred
- 4 and one of the public laws of nineteen hundred and twenty-
- 5 one and by chapter three of the public laws of nineteen hun-
- 6 dred and twenty-three, and as amended by chapter seventy-
- 7 four of the public laws of nineteen hundred and twenty-five,
- 8 is hereby amended by inserting in the tenth line thereof,

9 after the words "American Legion post" and before the 10 word "as" the words 'as a council of the Boy Scouts of 11 America'; so that said section as amended shall read as follows:

When seven or more persons desire to be incor-2 porated as proprietors of a social, military, literary, scien-3 tific or county law library; as a Masonic lodge or chapter 4 of any order or degree; as a Masonic association consisting 5 of members of different orders or degrees; as a lodge of 6 the Independent Order of Odd Fellows; as a lodge of the 7 Knights of Pythias; as a tribe of the Improved Order of 8 Red Men; as a division of the Sons of Temperance; as a 9 tent of the Rechabites; as a grange of Patrons of Hus-10 bandry; as a Council of the Sovereigns of Industry; as a II lodge of the Benevolent and Protected Order of Elks; as 12 a Grand Army post; as an American Legion post; as a 13 Council of the Boy Scouts of America; as a relief or benefit 14 association for mutual assistance; as a monument or me-15 morial association; as a society to promote temperance; as 16 a village improvement society; as an association for the 17 promotion of good municipal government; as a chamber 18 of commerce or board of trade; as a yacht club; or for the 19 purpose of preserving and maintaining a family homestead 20 and the rights of descendants and of members of the fam-21 ily therein; or for any literary, scientific, musical, charitable, 22 educational, social, military, agricultural, moral, religious, 23 or benevolent purpose; they may apply in writing to any 24 justice of the peace in the county, who may issue his war-25 rant directed to one of said applicants, requiring him to 26 call a meeting thereof at such time and place as the jus-27 tice may appoint.'
