STATE OF MAINE

.N THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-NINE

AN ACT Relating to the Board of State Assessors.

Be it enacted by the People of the State of Maine, as follows:

Section two of chapter nine of the revised statute of nine-

- 2 teen hundred and sixteen is hereby amended by striking out
- 3 the whole of said section and inserting in lieu thereof the
- 4 following:

"The members of such board shall be persons known to

- 2 possess knowledge of and training in the subject of tax-
- 3 ation and tax laws and skilled in matters pertaining thereto.
- 4 The chairman of said board shall devote his entire time to
- 5 the duties of his office; the associate members of such board

6 shall devote to the duties of their office such time as may 7 be required of them by the chairman. The board shall have 8 an office in the state house which shall be open for the 9 transaction of business every secular day, and may hold 10 sessions at any place other than the capitol when deemed 11 necessary in the performance of their duties.'

Section thirty-two of chapter one hundred and seventeen 2 of the revised statutes as amended by chapter one hundred 3 and eighty-three of the public laws of nineteen hundred and 4 seventeen, chapter one hundred and ninety-five of the public laws of nineteen hundred and nineteen, chapter one hundred and fifty-two of the public laws of nineteen hundred 7 and twenty-one, and chapter ninety-one of the public laws 8 of nineteen hundred and twenty-three, is hereby further 9 amended by striking out the whole of said section and inserting in lieu thereof the following:

'The annual salary of the chairman of the board of state 2 assessors shall be three thousand five hundred dollars; the 3 annual salary of the two associate members of said board 4 shall be two thousand dollars. All the members of said 5 board shall also receive their actual expenses incurred in 6 the performance of their official duties. They shall employ 7 a chief clerk and such other clerical assistance as may be 8 necessary.'

Chapter two hundred and two of the public laws of nine-2 teen hundred and nineteen is hereby amended by striking 3 out the whole of said chapter and inserting in lieu thereof 4 as follows:

'The board of state assessors is authorized to hold an 2 annual convention of city and town assessors in the city 3 of Augusta at such time as said board of state assessors 4 may designate. Said board may apply a sum not to exceed 5 three hundred dollars from their departmental appropriation 6 to defray the expenses of said convention.'
