STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-NINE

AN ACT Relating to Vaccination of Persons Employed in any Mill, Factory, Workshop or Other Manufacturing Establishment.

Be it enacted by the People of the State of Maine, as follows:
Section I. Section one hundred two of chapter nineteen
2 of the revised statutes is hereby amended by striking out
3 in the first and second lines the words "paper mill where
4 domestic or foreign rags are used in the manufacturing of
5 paper" and inserting in place thereof the words 'mill, fac6 tory, workshop or other manufacturing establishment which
7 employs at least fifteen persons,' so that said section as
8 amended shall read as follows:

'Sect. 102. No owner, agent or superintendent of any mill, 2 factory, workshop or other manufacturing establishment 3 which employs at least fifteen persons shall hire or admit 4 any person to work in or about said mill who has not been 5 successfully vaccinated or re-vaccinated within two years, 6 or to the satisfaction of the local board of health.'

Sect. 2. Section one hundred three of chapter nineteen 2 of the revised statutes is hereby amended by striking out 3 in the first and second lines the words "paper mill where 4 rags are used" and inserting in place thereof the words 5 'mill, factory, workshop or other manufacturing establish-6 ment which employs at least fifteen persons,' so that said 7 section as amended shall read as follows:

'Sect. 103. No person shall work in or about any mill, 2 factory, workshop or other manufacturing establishment 3 which employs at least fifteen persons, who has not been 4 successfully vaccinated or re-vaccinated within two years, 5 or to the satisfaction of the local board of health.'

Sect. 3. Section one hundred four of chapter nineteen 2 of the revised statutes is hereby amended by striking out 3 in the first and second lines the words "paper mill where 4 rags are used" and inserting in place thereof the words 5 'mill, factory, workshop or other manufacturing establish-6 ment which employs at least fifteen persons,' so that said 7 section as amended shall read as follows:

'Sect. 104. The owner, agent and superintendent in every 2 mill, factory, workshop or other manufacturing establish-

3 ment which employs at least fifteen persons shall every 4 year, in the months of February and September, make out 5 and deliver to the local board of health, a list containing 6 the names, ages, kind of work, and places of residence of 7 all persons employed in or about said mill.'

Sect. 4. Section one hundred five of chapter nineteen of 2 the revised statutes is hereby amended by striking out in 3 the second line the words "paper mill" and inserting in 4 place thereof the words 'mill, factory, workshop or other 5 manufacturing establishment which employs at least fifteen 6 persons,' so that said section as amended shall read as fol-7 lows:

'Sect. 105. In the months of March and October, an-2 nually, each and every person who is employed in a mill, 3 factory, workshop or other manufacturing establishment 4 which employs at least fifteen persons, shall be examined 5 by the local board of health as to whether he or she is suc-6 cessfully and sufficiently protected by vaccination, and the 7 local board of health shall in all cases be the judges of the 8 sufficiency of the protection by vaccination.'
