STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-NINE

AN ACT to Amend Chapter One Hundred and Sixty-two of the Public Laws of Nineteen Hundred and Twenty-seven as Applied to War Bond Sinking Fund.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Section one of chapter two hundred twenty2 one of the public laws of nineteen hundred twenty-one, as
3 amended by chapter one hundred sixty-two of the public
4 laws of nineteen hundred twenty-seven, is hereby amended
5 by inserting after paragraph "Third" of said section as
6 amended, a new paragraph designated as "Fourth," as fol-

'Fourth. To provide the annual sum necessary to pay

- 2 bonds issued under the provisions of chapter one hundred
- 3 eighty-seven of the public laws of nineteen hundred seven-
- 4 teen maturing during the fiscal years ending June thirtieth,
- 5 nineteen hundred thirty, to June thirtieth, nineteen hundred
- 6 thirty-two inclusive.'
 - Sect. 2. Said section one is hereby further amended by
- 2 renumbering paragraphs "Fourth" and "Fifth" thereof to
- 3 be paragraphs "Fifth" and "Sixth," and by adding to said
- 4 section a new paragraph designated "Seventh," as follows:
- 5 'Seventh. Insofar as the amount raised of said tax of one
- 6 mill on a dollar shall not be required at any time for the
- 7 purposes intended in the five preceding paragraphs, the
- 8 excess shall be deemed to be general revenue of the state,
- 9 available for appropriation by the legislature as it shall de-
- 10 termine,' so that said act, as amended, shall read as follows:
 - 'P. L., 1921, c. 221, sec. 1; relating to war bond sinking
- 2 fund and application of proceeds of bond, amended. Sec-
- 3 tion one of chapter two hundred twenty-one of the public
- 4 laws of nineteen hundred twenty-one is hereby amended
- 5 by striking out the whole of said section and inserting in
- 6 place thereof the following:
- 'Section 1. References to soldiers' bonus for Spanish war
- 2 veterans which failed of adoption, eliminated; funds made
- 3 available for pensions of dependents and other classes of
- 4 pensions; reimbursement of cities and towns for aid fur-
- 5 nished dependents out of fund, eliminated; sinking fund.
- 6 A tax of one mill on a dollar shall annually be assessed

7 upon all the property of the state according to the value

- 8 thereof, to be known as the war bond sinking fund. The
- 9 proceeds of this fund shall be used for the following pur-10 poses in the following order:

First. To pay the interest on all bonds issued under au-

- 2 thority of chapter one hundred and eighty-seven of the pub-
- 3 lic laws of nineteen hundred and seventeen.

Second. To pay the interest on all bonds issued or re-

- 2 issued under authority of chapter two hundred and sixty-
- 3 four of the public laws of nineteen hundred and nineteen,
- 4 as amended by chapter one hundred thirty-four of the pub-
- 5 lic laws of nineteen hundred and twenty-one.

Third. To provide the annual sum necessary for the sink-

- 2 ing fund established by chapter two hundred sixty-four,
- 3 section six, of the public laws of nineteen hundred nineteen.
- 4 as amended by said chapter one hundred thirty-four, of
- 5 the public laws of nineteen hundred twenty-one.

Fourth. To provide the annual sum necessary to pay

- 2 bonds issued under the provisions of chapter one hundred
- 3 eighty-seven of the public laws of nineteen hundred seven-
- 4 teen maturing during the fiscal years ending June thirtieth,
- 5 nineteen hundred thirty, to June thirtieth, nineteen hundred
- 6 thirty-two, inclusive.

Fifth. To pay the pensions for soldiers, sailors and

- 2 marines, their widows, children and other dependents un-
- 3 der any provision of law governing the same and all sums
- 4 payable under any provision of law for the relief of de-

5 pendents of soldiers, sailors and marines who served in 6 the World war, including pensions granted on account of 7 military service under the provisions of any resolve of the 8 legislature.

Sixth. To set aside in the fiscal year ending June thirtieth, 2 nineteen hundred and thirty-three, and in each of the fiscal 3 years thereafter to and including the year nineteen hundred 4 and thirty-seven, the sum of one hundred thousand dollars 5 each year, the same to be used to pay the bonds maturing 6 on May first, nineteen hundred and thirty-seven, said bonds 7 having been issued under authority of chapter one hundred 8 and eighty-seven of the public laws of nineteen hundred and 9 seventeen.

Seventh. Insofar as the amount raised of said tax of one 2 mill on a dollar shall not be required at any time for the 3 purposes intended in the six preceding paragraphs, the ex-4 cess shall be deemed to be general revenue of the state, 5 available for appropriation by the legislature as it shall de-6 termine.'
