STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-NINE

AN ACT Relating to the State Department of Health.

Be it enacted by the People of the State of Maine, as follows:

Section 1. P. L. 1917, c. 197, sect. 8; 1919, c. 172; 1921,

2 c. 162; 1923, c. 217; 1927, c. 206; relating to appropriation

3 for state department of health, amended. Section eight of

4 chapter one hundred ninety-seven of the public laws of

5 nineteen hundred seventeen, as amended by chapter one

6 hundred seventy-two of the public laws of nineteen hun
7 dred nineteen, as amended by chapter one hundred sixty
8 two of the public laws of nineteen hundred twenty-one, as

9 amended by chapter two hundred seventeen of the public

10 laws of nineteen hundred twenty-three, as amended by

11 chapter two hundred six of the public laws of nineteen 12 hundred twenty-seven, is hereby further amended by strik-13 ing out the words "fifty-eight" and inserting in place there-14 of the words 'sixty-four,' so that said section, as amended, 15 shall read as follows:

'Sect. 8. Appropriation increased to sixty-four thousand 2 dollars. The sum of sixty-four thousand dollars shall be 3 annually appropriated for the purposes set forth in sec-4 tions one to six inclusive, and section seven of this act.'

Sect. 2. P. L. 1919, c. 172, sect. 2; 1921, c. 162; 1923, c. 2 217; relating to appropriation for health districts, local 3 health officers, etc., amended. Section two of chapter one 4 hundred seventy-two of the public laws of nineteen hun-5 dred nineteen, enacting section sixteen as an additional sec-6 tion to chapter one hundred ninety-seven of the public 7 laws of nineteen hundred and seventeen, as amended by 8 chapter one hundred sixty-two of the public laws of nine-9 teen hundred twenty-one, as amended by chapter two hun-10 dred seventeen of the public laws of nineteen hundred 11 twenty-three, is hereby further amended by striking out the 12 word "thirty-eight" in the second line thereof and sub-13 stituting therefor the word 'forty-four,' so that said sec-14 tion sixteen, as amended, shall read as follows:

'Sect. 16. Appropriation increased from thirty-eight 2 thousand dollars to forty-four thousand dollars. The sum 3 of forty-four thousand dollars shall be appropriated an-4 nually to the state department of health for the purpose of

5 carrying out the provisions of sections six, ten, eleven, 6 twelve, thirteen and fourteen.'
