STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-NINE

AN ACT Relating to Moose.

Be it enacted by the People of the State of Maine, as follows:

The second and third paragraphs of section thirty-seven

- 2 of chapter two hundred nineteen of the public laws of nine-
- 3 teen hundred seventeen, as amended, are hereby further
- 4 amended by striking out the whole of said paragraphs and
- 5 inserting in place thereof the following:

'No person shall, at any time, hunt, pursue, catch or kill

- 2 any bull moose in the county of Androscoggin, Cumber-
- 3 land, Franklin, Hancock, Kennebec, Knox, Lincoln, Oxford,
- 4 Piscataquis, Sagadahoc, Somerset or York, under a penalty

5 of not less than two hundred dollars nor more than three 6 hundred dollars, and costs, for each offense, or imprison-7 ment for sixty days, or both said fine and imprisonment; 8 nor shall any person, under the same penalty, have in pos-9 session at any time any bull moose, or part or parts thereof. To taken in either of said counties.

No person shall, at any time, hunt, pursue, catch or kill 2 any bull moose in the county of Aroostook, Penobscot, 3 Waldo or Washington, except from the twentieth day of 4 November to the thirtieth day of November, both days in-5 clusive, in each year, nor shall any person take, catch or kill 6 more than one bull moose, or have in possession more than 7 one bull moose, or part or parts thereof, whenever or wher-8 ever taken, caught or killed, under a penalty of not less 9 than two hundred dollars, nor more than three hundred 10 dollars, and costs, for each offense, or imprisonment for II sixty days, or both said fine and imprisonment. No person 12 shall, under the same penalty, at any time have in possession 13 any bull moose, or part or parts thereof, in closed season. 14 whenever or wherever taken, caught or killed, except a per-15 son who has lawfully killed a bull moose in open season 16 shall have a reasonable time in which to transport the same 17 to his home, and may have the same in possession at his 18 home in closed season.'
