STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND TWENTY-NINE

AN ACT Relating to the Terms of Superior Court for the
County of Kennebec.

Be it enacted by the People of the State of Maine, as follows:

*R. S., c. 82, Sec. 85; 1921, c. 111; relating to terms of
2 Kennebec Superior Court, amended.* Section eighty-five of
3 chapter eighty-two of revised statutes, as amended by
4 chapter one hundred eleven of the public laws of nineteen
5 hundred twenty-one, is hereby further amended by striking
6 out the word "second" in the first line of said section and
7 inserting in place thereof the word 'first,' and by striking
8 out the word "first," in the second line of said section and
9 inserting in place thereof the word 'second,' and by striking

10 out the word "second" appearing before the words "Tues-
11 days of January" in the fifth line of said section, and in-
12 serting in place thereof the word 'first,' and by striking out
13 the word "first" appearing before the words "Tuesdays of
14 April" in the fifth line of said section, and inserting in place
15 thereof the word 'second,' so that said section, as amended,
16 shall read as follows:

'Sect 85. *Augusta Terms changed from second Tuesday
2 of January to first Tuesday of January; April and Septem-
3 ber terms changed from first Tuesdays to second Tuesdays.*
4 Said court shall be held at Augusta on the first Tuesday
5 of January, and the second Tuesdays of April and Septem-
6 ber, and at Waterville on the fourth Tuesday of May and
7 the second Tuesday of November; but the criminal business
8 of said county shall be transacted at the terms held on the
9 first Tuesday of January, and the second Tuesdays of April
10 and September, together with civil business. The judge of
11 said court may continue any case pending in said court
12 without costs, when in his judgment justice may require it,
13 in order to give the parties in interest opportunity to try any
14 such case in either Waterville or Augusta in said county.'
