STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND TWENTY-NINE

AN ACT to Change the Name of Cumberland Agricultural
and Horticultural Society; to Enlarge the Board of Directors
and to Increase the Amount of Property the Society May
Hold.

Be it enacted by the People of the State of Maine, as follows:

Section 1. *Name Changed to "Western Maine Agricultural
2 tural Exposition."* The name of "Cumberland Agricultural
3 and Horticultural Society" as fixed by chapter two hundred
4 seventeen of the private and special laws of eighteen hun-
5 dred and thirty-two is hereby changed to "Western Maine
6 Agricultural Exposition," and all the rights, powers and
7 privileges granted to said corporation by said chapter two

8 hundred seventeen and acts amendatory thereof or addi-
9 tional thereto under the name of "Cumberland Agricultural
10 and Horticultural Society" shall hereafter be held, exercised
11 and performed by said corporation under the name of
12 "Western Maine Agricultural Exposition."

Sect. 2. *Number of Directors Increased.* The affairs of
2 said corporation shall be managed by a board of directors
3 to consist of not less than seven nor more than thirty-six
4 to be elected by the members of the society in accordance
5 with the by-laws and seven directors shall constitute a
6 quorum of said board if the membership exceeds fifteen,
7 and if composed of less than fifteen, a majority shall con-
8 stitute a quorum. The directors may elect an executive
9 committee to consist of not less than three nor more than
10 seven, which committee in the recess of the board of direc-
11 tors, shall manage the affairs of the corporation.

Sect. 3. *Corporation Authorized to Hold Real and Per-
2 sonal Estate.* The corporation may take and hold any es-
3 tate, real or personal, to be used and employed exclusively
4 for the promotion and improvement of agriculture, horticul-
5 ture and animal husbandry and all the arts connected there-
6 with or for the improvement of any industry carried on in
7 the state of Maine.
