STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-NINE

AN ACT Relating to the Relicensing and Registration of Undertakers.

Be it enacted by the People of the State of Maine, as follows:

Sections thirty and thirty-one of chapter one hundred

- 2 forty-one, of the public laws of nineteen hundred twenty-
- 3 seven, amending chapter nineteen of the revised statutes,
- 4 are hereby amended by striking out both of said sections.
- 5 and inserting in place thereof the following:

'Sect. 30. Fees, expiration and renewal of licenses and 2 certificates of registration. The fee for examination un-

3 der section twenty-seven shall be five dollars, and all 4 licenses and certificates of registration which have been, 5 or may be issued to undertakers and embalmers by the 6 board of examiners, shall expire on the thirty-first day of 7 December, annually, provided that the licenses and certifi-8 cates of registration hereafter issued, shall be valid and 9 shall not expire until the last day of the following year. 10 Any persons holding an embalmer's license or certificate II of registration, issued under the provisions of this or any 12 other law, may have the same renewed by making and 13 filing with the secretary of said board of examiners an 14 application therefor within thirty days preceding the ex-15 piration of his, or her, license or certificate of registra-16 tion, upon blanks prescribed by said board, and upon the 17 payment of a renewal fee of two dollars, provided, how-18 ever, that any person neglecting or failing to have his, or 19 her, license or certificate of registration, renewed as above, 20 may have the same renewed by making application there-21 for within thirty days after the date of such expiration, 22 and upon the payment of four dollars, revival and re-23 newal fee.

Sect. 31. Fund and purposes thereof. The money thus 2 received shall constitute a permanent fund for carrying on 3 the work of the board and the compensation of its mem-4 bers, and for such expenses as may be necessarily incurred 5 from time to time by said board on account of investiga-6 tions which said board may be required to make by rea-

7 son of this act; and for such educational purposes as said 8 board may deem for the best interests and advantage to 9 the embalmers and undertakers of the state of Maine, pro10 vided always, that none of the expenses designated here11 under shall reduce the fund hereby created under the sum
12 of one thousand dollars.'
