Bangor, Maine, December 28, 1928.

We the undersigned, to whom was referred the assessment of damages to land of John M. Norris, in Hampden, Maine, occupied by him for a dwelling house, occasioned by the change of the grade of the State Highway passing the same in Hampden, Maine, met at the premises and viewed the same. Both Mr. Norris and the State Highway Commission having been notified of the time and place of hearing, Mr. Norris appeared in person with counsel and Mr. Charles Murray appeared representing the Commission. After hearing the parties and viewing the premises and considering the matter we determine that Mr. Norris has been damaged by the change of the grade of said highway in the sum of Ten Thousand Dollars (\$10,000.00), the same to be paid to him by the State of Maine in full for all damages to said property by the change of grade in said highway.

Extract from Commission Record of November 20-21, 1928

The Commission had a conference with Louis Stearns of Bangor and J. M. Norris. This conference was in regard to damage claimed by Mr. Norris on account of raising the grade adjacent to his property in Hampden on Federal Aid Project 84-F. Mr. Stearns stated that before the road was built Mr. Norris' property was about level with the grade of the highway and that the new grade of the road is much higher, making access to Mr. Norris' property difficult and causing water to drain under his land. Mr. Stearns stated that he considered that Mr. Norris' property had been damaged in the amount of \$15,000. The Commission stated that they could not agree to this amount and Chairman Smith suggested that a board of three disinterested men be named to appraise the damage and suggested that this board consist of Ned Merrill of Skowhegan, Herbert Wadsworth of Winthrop and Fred Gilbert of Hampden. The Commission stated that they would be willing to agree to the award of damage made by this board. Mr. Stearns, in behalf of Mr. Norris, stated that the personnel of this board as named by Mr. Smith was satisfactory and stated that he would draw up a form of agreement.

Extract from Commission Record of December 12, 13, 14, 1928 The Commission noted letter, under date of December 4, from Fred A. Gilbert of Bangor and a letter, under date of December 6, from Edward F. Merrill of Skowhegan, advising that they would act as members of a board for appraising damage to the Norris property in Hampden. Mr. Clifford stated that he talked with Herbert E. Wadsworth of Winthrop, who was suggested as the third member of this board, and that Mr. Wadsworth had advised him that he would act in the matter. The Commission requested Mr. Barrows to arrange with Mr. Gilbert for a date on which this board will investigate.

Clyde H. Smith, Charles Murray, Edwin T. Clifford, State Highway Commissioners, Augusta, Maine. Dear Sirs:

This is in reference to the claims of John M. Norris for damages caused by raising the grade of the Atlantic Highway fronting on his premises in Hampden. It is my understanding that we are to leave this to arbitration. In this connection we have agreed upon Fred A. Gilbert of Hampden, Edward F. Merrill of Skowhegan and Herbert E. Wadsworth of Winthrop. Their finding or assessment of damages is to be binding, final and conclusive. I understand that the State Highway Commission or Mr. Norris is to furnish them any information or data which they may request.

If this is satisfactory, will you please advise the above-named and request that they proceed at once?

Of course, this agreement is without prejudice to our rights to proceed under the statute, if for any reason our appraisers fail to act or in case their award shall not be paid.

At a meeting on November 20 the Commission had a conference with John M. Norris of Hampden and his attorney, Louis C. Stearns of Bangor, in connection with damages claimed by Mr. Norris on account of raising the grade of the highway adjacent to his property in Hampden.

At this conference the Commission and Mr. Norris failed to arrive at a satisfactory basis of settlement and the Commission suggested that the assessment of damages be left with a board of three disinterested parties and that the amount of damages as determined by this board would be binding, final and conclusive. Chairman Smith suggested that the board consist of Fred A. Gilbert of Hampden, Edward F. Merrill of Skowhegan and Herbert E. Wadsworth of Winthrop. This suggestion met with the approval of Mr. Norris and his attorney.

The Commission have requested me to notify each of you

gentlemen of this action and to request that you advise us if you will be willing to act in this matter.
