## STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE  
HUNDRED AND TWENTY-NINE

RESOLVE, in Favor of Charitable and Benevolent Institutions, for the Care and Support of Certain Persons.

---

Resolved: That there be, and hereby is, appropriated for  
2 the fiscal year from July first, nineteen hundred and twenty-  
3 nine to June thirtieth, nineteen hundred and thirty, the sum  
4 of sixty-three thousand three hundred and fifty dollars  
5 (\$63,350.00), and for the fiscal year from July first, nine-  
6 teen hundred and thirty to June thirtieth, nineteen hundred  
7 and thirty-one, the sum of sixty-two thousand three hun-  
8 dred and fifty dollars (\$62,350.00):

For the care and support of children under sixteen years  
2 of age, including those supported away from their parents

3 under the provisions of sections fifty-one to fifty-five inclu-  
 4 sive, chapter sixty-four of the revised statutes, and acts  
 5 amendatory thereof, at not to exceed three dollars and fifty  
 6 cents per week, including direct payment from sources other  
 7 than the state:
