### STATE OF MAINE

# IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-NINE

AN ACT Relating to the Board of State Assessors.

Be it enacted by the People of the State of Maine, as follows:

Section two of chapter nine of the revised statutes of 2 nineteen hundred and sixteen is hereby amended by strik-

- 3 ing out the whole of said section and inserting in lieu there-
- 4 of the following:

'The members of such board shall be persons known to

- 2 possess knowledge of and training in the subject of tax-
- 3 ation and tax laws and skilled in matters pertaining there-
- 4 to. The chairman of said board shall devote his entire time
- 5 to the duties of his office; the associate members of such
- 6 board shall devote to the duties of their office such time as

7 may be required of them by the chairman. The board shall 8 have an office in the state house which shall be open for 9 the transaction of business every secular day, and may hold 10 sessions at any place other than the capitol when deemed 11 necessary in the performance of their duties.'

Section thirty-two of chapter one hundred seventeen of 2 the revised statutes as amended by chapter one hundred 3 eighty-three of the public laws of nineteen hundred twenty-4 seven, chapter one hundred ninety-five of the public laws 5 of nineteen hundred nineteen, chapter one hundred fifty-6 two of the public laws of nineteen hundred twenty-one and 7 chapter ninety-one of the public laws of nineteen hundred 8 twenty-three, is hereby further amended by striking out the 9 the whole of said section and inserting in lieu thereof the 10 following:

"The annual salary of the chairman of the board of state 2 assessors shall be three thousand five hundred dollars; the 3 annual salary of the two associate members of said board 4 shall be two thousand five hundred dollars. All the mem-5 bers of said board shall also receive their actual expenses 6 incurred in the performance of their official duties. They 7 shall employ a chief clerk and such other clerical assistance 8 as may be necessary."

Chapter two hundred and two of the public laws of nine2 teen hundred nineteen is hereby amended by striking out
3 the whole of said chapter and inserting in lieu thereof as
4 follows:

"The board of state assessors is authorized to hold an an-2 nual convention of city and town assessors in the city of 3 Augusta at such time as said board of state assessors may

4 designate. Said board may apply a sum not to exceed three

5 hundred dollars from their departmental appropriation to

6 defray the expenses of said convention.'
