STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND TWENTY-NINE

RESOLVE, to Appropriate Money for the Payment of the Account of William E. Brown, a Member of the State Highway Police, in One Thousand Nine Hundred and Twenty-four.

Whereas, one William E. Brown was employed in the enforcement of the motor vehicle laws from April seven to October twenty-four, one thousand nine hundred and twenty-four, and

Whereas, the records in the office of the state auditor show that there is due to said William E. Brown, an amount accumulated by him and credited to the purchase of his motorcycle while employed upon the highways of the state of Maine, and

Whereas, said William E. Brown is in need of the amount due him and if he does not promptly receive the same will have no means to support himself, his family now being ill and in distress and are recipients of aid from veterans' organizations, and

Whereas, it is immediately necessary for the protection of the public peace, health and safety, that said money be made immediately available for the use of said William E. Brown. These facts in the opinion of the legislature constituting an emergency within the meaning of the constitution.

Resolved, That there be appropriated three hundred forty
2 dollars and eight cents to pay the amount due said William
3 E. Brown. In view of the emergency cited in the preamble,
4 this resolve should take effect when approved.

STATEMENT OF FACTS

The records in the office of the state auditor show that Mr. Brown began his employment under the arrangement with Capt. H. A. Miller, April seventh, one thousand nine hundred and twenty-four, and that he continued in that employment until October twenty-four, one thousand nine hundred and twenty-four. In this period there appear credits towards the purchase of his motorcycle as follows:

April 7-30	\$35.44
May 1-31	47.08
July 1-14	43.76
July 15-31	37.84
Aug. 1-15	38.24
Aug. 16-31	44.96
Sept. 1-15	32.24
Oct. 1-15	36.20
Oct. 16-24	24.32

\$340.08

These amounts so withheld are still due to Mr. Brown.
