STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND TWENTY-NINE

AN ACT to Incorporate the Maine Pharmaceutical Association.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Charles S. Pierce, Francis F. Frawley, Lewis
2 O. Barrows, Roy M. Hescock, Dr. M. L. Porter and James
3 H. Allen, and all such persons as are now members of an
4 association known as the Maine Pharmaceutical Association,
5 or shall hereafter become members of the same, are hereby
6 constituted a body politic in law and in fact, by the name
7 of the Maine Pharmaceutical Association, for the purpose
8 of cultivating, improving and making known the principles
9 of pharmacy, its collateral branches of science, and the best
10 modes of preparing medicines and their compounds, and
11 of giving instruction in the same, by public lectures or

12 otherwise, as circumstances shall render advisable; and may
13 hold real and personal estate to an amount not exceeding
14 twenty thousand dollars.

Sect. 2. The said association may establish by-laws and
2 rules for its government and regulation, and for the pre-
3 servation and application of the funds thereof not repug-
4 nant to the constitution and laws of the United States, or
5 of the state of Maine; and shall have power to do all and
6 singular such acts as may be proper and necessary for the
7 establishment of said association, and for the promotion and
8 fulfilment of its objects.

Sect. 3. The officers of the association shall be a presi-
2 dent, three vice presidents, recording secretary, correspond-
3 ing secretary, treasurer and auditor, whose respective duties
4 may be assigned by the by-laws, and who shall be elected
5 by printed or written ballots at the stated annual meeting
6 on the third Tuesday of July of each year, and any vacancy
7 may be filled by a special election by the members of said
8 association. There shall also be elected at said annual
9 meeting, an executive committee of six members, who, with
10 the other officers of the association above enumerated, shall
11 constitute a board of trustees, and whose duties shall be
12 defined by the by-laws, and who shall serve one year or until
13 others are chosen to fill their place. Said board, of which
14 not less than five shall constitute a quorum, shall conduct
15 the ordinary affairs of the association. They may make
16 such rules and regulations, and do such other things for

17 the support and government of the pharmaceutical asso-
18 ciation as they may deem fit and proper, and perform such
19 duties as are or may be from time to time committed to
20 them by said association; their acts, however, to be sub-
21 mitted to the association for revision, at each stated meeting
22 of the association.

Sect. 4. The board of trustees shall have power to issue
2 certificates of membership. The association may have the
3 right to issue scrip stock, execute bonds, mortgages, con-
4 veyances, and to sell its property, whether in real estate,
5 books, productions of nature or art, under the common seal
6 of the association, and acknowledged by its president, or in
7 any way so dispose of its possessions as to promote phar-
8 maceutical education, and the mutual advancement of its
9 members, and the elevation of the art and business of the
10 pharmacist in the community.

Sect. 5. If the annual election for officers of the associa-
2 tion and members of the board of trustees for any cause
3 shall not be held on the day before mentioned, the said
4 corporation shall not be thereby dissolved, but the officers
5 and trustees shall continue in office until a new election.

Sect. 6. The corporation hereby created, shall be sub-
2 ject to the provisions, and possess the general powers speci-
3 fied in reference to kindred and educational societies in the
4 revised statutes of the state of Maine; and the legislature
5 may at any time modify, alter or repeal this act.
