### STATE OF MAINE

#### IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-NINE

AN ACT Relating to Portland Gas Light Company.

Be it enacted by the People of the State of Maine, as follows: Section 1. Charter rights enlarged. Portland Gas Light
2 Company is hereby authorized to extend its pipe lines into
3 and along the streets and ways of and to produce, manu4 facture, sell and distribute gas and exercise all its fran5 chises in the cities of South Portland and Westbrook and
6 the towns of Cape Elizabeth, Scarboro, Gorham, Wind7 ham, Falmouth, Cumberland and Varmouth, all in the coun8 ty of Cumberland.

Sect. 2. May merge or consolidate with any corporation 2 doing business in said territories. Portland Gas Light ComSENATE-No. 101

3 pany may acquire, by purchase, merger or consolidation, the 4 properties and franchises of any person, firm or corpora-5 tion doing a similar business in any of said cities or towns, 6 all and each of which are hereby authorized to sell and 7 transfer their several properties and franchises to and/or 8 to merge and/or consolidate with said Portland Gas Light o Company. From and after such sale and purchase, merger 10 or consolidation said Portland Gas Light Company may, II in respect to the property and franchises so acquired and 12 in respect to its own property and franchises exercise for 13 its purposes not only all rights, powers, privileges and fran-. 14 chises now held and hereafter granted to it, but also all the 15 powers and privileges theretofore held and exercised by such 16 other persons, firms and corporations. Within the limits 17 of the aggregate amount thereof at any time by its charter 18 authorized to be issued, Portland Gas Light Company may 19 issue its stock and bonds for the purposes hereof and for 20 the installation, construction, enlargement and operation of 21 its properties in said cities and towns.

Sect. 3. Certain acts repealed. Section two of chapter 2 three hundred eighty-five of the private and special laws of 3 nineteen hundred and five is hereby specifically repealed, 4 and all provisions of the acts of incorporation of said Port-5 land Gas Light Company and all acts amendatory thereof 6 and additional thereto inconsistent with this act are hereby 7 repealed.

Sect. 4. Existing statutes not affected; subject to pro-

2 visions of R. S., c. 55. Nothing herein contained, except 3 as specifically provided in section three, is intended to re-4 peal or shall be construed as repealing the whole or any 5 part of any existing statute, and all the rights and duties 6 herein mentioned, when acquired and while owned or con-7 trolled by Portland Gas Light Company, shall be exercised 8 and performed in accordance with all the applicable pro-9 visions of chapter fifty-five of the revised statutes and acts 10 amendatory thereof or additional thereto.
