STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND TWENTY-NINE

AN ACT to Amend and Extend the Charter of Kennebec Reservoir Company, Said Charter Being Chapter 113 of the Private and Special Acts of 1927.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Section one (1) of chapter one hundred thirteen of the private and special acts of nineteen hundred twenty-seven is hereby amended by striking out the name of Garrett Schenck and inserting in the place thereof the name W. A. Whitcomb.

Sect. 2. Section seven (7) of said act is hereby amended by striking out the first sentence of the second paragraph of said section seven, which reads as follows: "This cor-

4 poration shall remove all growth on the area flowed by it
5 seasonably to prevent it from falling and being carried away
6 by the water, and in any event within four years of the
7 commencement of said flowage," and inserting in the place
8 of said sentence so stricken out the following: 'This cor-
9 poration shall within four years from the commencement
10 of flowage cut or remove all growth on the flowed area to
11 such an extent that no growth thereon shall protrude above
12 the surface of the water between June first and December
13 first next following of each year.'

Sect. 3. Section thirteen (13) of said act is hereby amend-
2 ed by striking out the paragraph thereof marked (a) and
3 being the second paragraph of said section and inserting in
4 the place thereof the following:

'(a) The lessee shall pay therefor to the treasurer of the
2 state an annual rental of five thousand dollars until July
3 first following the completion of said dam, and thereafter-
4 ward of twenty-five thousand dollars, payable on or before
5 the thirtieth day of June of each year, said rental shall begin
6 to accrue from the first day of July following the acceptance
7 of this charter as aforesaid.'

Sect. 4. The rights, powers and privileges of the Kennebec
2 Reservoir Company, which were granted by chapter one
3 hundred thirteen of the private and special laws of nineteen
4 hundred twenty-seven and as amended by this act, be ex-
5 tended for the period of two years from the date when this
6 act takes effect; and the persons named in said act as hereby

7 amended, their associates, successors and assigns shall have
8 all the rights, powers and privileges that were granted them,
9 or their predecessors, by said act and the amendments there-
10 to contained herein to be exercised in the same manner and
11 for the same purposes as specified in said act as hereby
12 amended.
