#### STATE OF MAINE

## IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-NINE

AN ACT Providing for the Protection of Owners of Electric Storage Batteries.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Rental batteries as used in this act are defined

- 2 as an electric storage battery, properly marked, loaned,
- 3 rented or furnished for temporary use by any person, firm
- 4 or corporation engaged in the business of buying, selling,
- 5 repairing, or recharging electric storage batteries. All said
- 6 persons, firms or corporations must mark any such rental
- 7 batteries belonging to them with the words "Been made (or
- 8 abbreviated B. M.) a rental," together with such words and
- 9 name of city or town as shall identify such batteries as the

10 property of the person, firm or corporation so marking them
11 as such.

- Sect. 2. It shall be unlawful for any person, firm or cor-2 poration to mark any battery which is not the property of 3 such person, firm or corporation so marking same as a 4 rental.
- Sect. 3. It shall be unlawful to sell or dispose of, or give 2 away any rental battery marked as above without removing 3 all identification marks from same.
- Sect. 4. It shall be unlawful for any person, firm or cor2 poration other than the owner thereof to remove, destroy,
  3 or deface the word rental or any of the identification marks
  4 on any rental battery that have been placed on a rental bat5 tery to identify the same as belonging to or being the prop-

6 erty of any person, firm or corporation.

- Sect. 5. It shall be unlawful for any person, firm or cor2 poration other than the owner thereof to repair, recharge
  3 or give away or dispose of, to any other person, firm or
  4 corporation any rental battery marked by the owner thereof,
  5 as provided for in this act.
- Sect. 6. It shall be unlawful for any person, firm or cor2 poration to retain, keep, or have in his, their or its posses3 sion for a longer period than ten (10) days from the date
  4 same was rented or loaned by owner, without the written
  5 consent of the owner any rental battery marked as such
  6 by the owner thereof as provided for in this act.
  - Sect. 7. Any person, firm or corporation and the officers,

2 agents, employees and members of any firm or corporation 3 violating any part of this act, shall be guilty of a violation 4 of this act and upon conviction thereof shall be sentenced 5 to pay a fine not exceeding one hundred dollars, and not 6 less than ten dollars, and the cost of court, or be imprisoned 7 for a term not exceeding thirty days and not less than ten 8 days or both at the discretion of the court.
