STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-NINE

AN ACT Relating to Exemptions from Taxation.

Be it enacted by the People of the State of Maine, as follows:

Paragraph IX of section six of chapter ten of the revised

- 2 statutes, as amended by chapter one hundred five of the
- 3 public laws of nineteen hundred nineteen, as further amend-
- 4 ed by chapter one hundred nineteen of the public laws of
- 5 nineteen hundred twenty-one, as further amended by chapter
- 6 seventy-five of the public laws of nineteen hundred twenty-
- 7 three, as further amended by chapter sixty-three of the
- 8 public laws of nineteen hundred twenty-seven, relating to
- 9 exemptions from taxation is hereby further amended so

10 that, as amended, said section shall read as follows:

'The polls and the estates of persons who by reason of age, 2 infirmity or poverty, are in the judgment of the assessors 3 unable to contribute toward the public charges; the polls 4 of all soldiers and sailors who served in the army or navy 5 of the United States in the war of eighteen hundred sixty-6 one and five, and were honorably discharged from such 7 service; the polls of all soldiers, sailors and marines who 8 receive state pension; the polls of all soldiers, sailors and 9 marines who served in the war with Spain; the polls of all 10 disabled veterans of the world war, namely, soldiers, sailors 11 and marines who are receiving compensation or vocational 12 training from the United States government on account of 13 disabilities incurred in or aggravated by service in the world 14 war; and the estates to the value of five thousand dollars 15 of all soldiers, sailors and marines, or the widows of sold-16 iers, sailors or marines who served in the war of eighteen 17 hundred sixty-one and five, the war with Spain or the 18 world war, and were honorably discharged who shall have 19 reached the age of fifty-five years, or are receiving a pen-20 sion or compensation from the pension bureau or United 21 States Veterans' Bureau for total disability, and of all per-22 sons, residents of this state, determined to be blind within 23 the definition provided by chapter three hundred of the 24 public laws of nineteen hundred seventeen by the examiner 25 of the blind provided by said chapter; provided, however, 26 that any such soldier, sailor or marine, or blind person, or

27 widow of such soldier, sailor or marine, or blind person, 28 who desire to pay said tax may, on or before the first day 29 of April in each year, notify in writing the assessors of the 30 city, town or plantation in which he or she resides of his 31 or her desire to pay said tax, whereupon said assessors shall 32 assess said tax against said soldier, sailor or marine, or blind 33 person, or widow of said soldier, sailor or marine or blind 34 person, and said soldier or sailor or marine or blind person, 35 or widow of said soldier, sailor, marine or blind person 36 shall be legally holden to pay said tax; and provided fur-37 ther, that no property conveyed to such soldier, sailor or 38 marine or blind person, or widow of such soldier, sailor or 39 marine or blind person, for the purpose of obtaining exemp-40 tion from taxation under this section shall be so exempt, 41 and any attempt to obtain such exemption by means of such 42 fraudulent conveyance shall be punished by a fine of not 43 less than one hundred dollars.'
