## STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-NINE

AN ACT Relating to the Powers of the State Highway Police.

Whereas, the state highway police have been effective in the enforcement of all the penal laws of the state; and

Whereas, such state highway police have been withdrawn from active enforcement of the laws save those pertaining to motor vehicles; and

Whereas, there is reasonable apprehension on the part of the citizens of Maine lest criminals from other states enter Maine for the purpose of committing offenses against our laws, using such means and force as they see fit, even to the taking of life; and Whereas, if this act is obliged to take its regular course of awaiting ninety days after the adjournment of the legislature there might result depredations of serious consequence to lives and property; and

Whereas, in the judgment of the legislature these facts create an emergency within the meaning of the constitution of the state of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now therefore

Be it enacted by the People of the State of Maine, as follows:

Section 1. Section two of chapter one hundred forty-2 four of the public laws of nineteen hundred and twenty-five 3 is hereby amended by striking out in the seventh, eighth 4 and ninth lines thereof the following: "The chief and mem-5 bers of the state highway police shall have the same power 6 to serve criminal processes against such offenders as sher-7 iffs" and inserting in place thereof the following: 'In addi-8 tion to such duties and powers, the chief and members of of the state highway police hereby are vested with the same 10 powers and duties throughout the several counties of the II state as deputy sheriffs have in their respective counties to 12 serve criminal processes, to investigate and prosecute viola-13 tors of any law of this state and to arrest the offenders 14 thereof,' and by adding after the word "duties" in the first 15 line of said section the words 'and powers,' and by adding 16 after the word "power" in the ninth line in said section the 17 words 'and duty,' so that said section as amended shall read 18 as follows:

'Sect. 2. The specific powers and duties of the state high-2 way police shall be to patrol the state highways and other 3 important ways, especially outside the compact portion of 4 cities and towns, for the purpose of enforcing the provi-5 sions of this act and all laws relating to motor driven and 6 horse drawn vehicles and all rules and regulations in regard 7 thereto, and of arresting all violators thereof and prosecut-8 ing all offenders against the same. In addition to said du-9 ties and powers, the chief and the members of the state 10 highway police hereby are vested with the same powers and II duties throughout the several counties of the state as deputy 12 sheriffs have in their respective counties to serve criminal 13 processes, to investigate and prosecute violators of any law 14 of this state and to arrest the offenders thereof, and also 15 the same power and duty as sheriffs have to arrest without 16 warrant and detain persons found violating or attempting 17 to violate any other penal law of the state until a legal war-18 rant can be obtained. They shall immediately report by 10 telephone or other expeditious means to the proper author-20 ities all information and complaints by them received con-21 cerning the commission of any crime, and shall have the 22 same rights as sheriffs to require aid in executing the duties 23 of their office. They may serve subpoenas, notices and pro-24 cesses issued by the secretary of state or the state highway 25 commission under authority of this act or chapter two hun-26 dred and eleven of the public laws of nineteen hundred and 27 twenty-one and acts amendatory thereof. They shall also

28 at all times be subject to the call of the governor for 29 emergency purposes at his discretion.

The state highway police, sheriffs and deputy sheriffs, con-

- 2 stables, city marshals and police officers of cities and towns
- 3 shall so far as possible cooperate in the detection of crime,
- 4 the arrest and prosecution of criminals, and the preservation
- 5 of law and order throughout the state.'

Sect. 2. In view of the emergency cited in the preamble,

2 this act shall take effect when approved.
