STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND TWENTY-NINE

AN ACT to Establish the Territorial Limits of the South Paris
Village Corporation.

Be it enacted by the People of the State of Maine, as follows:

Preamble. Whereas, the territorial limits of the South
2 Paris Village Corporation as described in the private and
3 special laws of eighteen hundred sixty-six, chapter seventy-
4 five, and acts amendatory thereto are indefinite and whereas
5 the inhabitants of said South Paris Village Corporation
6 desire to have the territorial limits definitely established.

Section 1. The municipal officers of South Paris Village
2 Corporation are hereby authorized to establish the territorial

3 limits of said corporation, and are authorized to include
4 land embraced within the following limits: commencing at
5 the center of Alpine street at the northeasterly corner of a
6 piece of land set off to the town of Norway in eighteen
7 hundred fifty-nine; thence easterly on the southerly line of
8 lot nine (9) range one (1) to the southeasterly corner;
9 thence northerly on the range line to the northwesterly cor-
10 ner of lot nine (9) range two (2); thence easterly on said
11 lot line to the southeasterly corner of the Emery Record
12 lot; thence northerly on the easterly line of the Record
13 lot and a continuation of the same to the southerly line of
14 the Otis Swift lot, now owned by Walter Gray; thence east-
15 erly on said Gray south line to the Gray meadow, so called;
16 thence southerly by said Gray meadow to the Little An-
17 droscoggin river; thence southerly by said river to the north
18 line of lot nine (9) range three (3); thence westerly by
19 the north line of said lot to the northeast corner; thence
20 southerly by said range line to the Burnell brook and the
21 northeast corner of the J. Bickford lot, so called; thence
22 westerly and southerly by said Bickford lot to the East
23 Oxford road; thence northerly and westerly by the west
24 line of the old William Rice lot to the northerly line of lot
25 six (6); thence westerly on the said lot line to the Little
26 Androscoggin river; thence down said river to the Norway
27 town line; thence northerly on said town line to the point
28 of beginning, together with the inhabitants thereon.

Sect. 2. *Local referendum provided for.* This act shall
2 not be operative until it is ratified by a majority vote of
3 the legal voters of South Paris Village Corporation at an
4 annual or special meeting of said corporation called by a
5 warrant containing an article for the purpose.
