STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND THIRTY-ONE

AN ACT relating to the hunting of water fowl or any other wild bird in Back Bay, so-called, in Portland.

Be it enacted by the People of the State of Maine, as follows:

Section eighty-five of Chapter thirty-eight of the Revised Statutes of Maine, 1930, is hereby amended by adding thereto after the word "bridge" in the fourth line thereof, the following: 'or within the area enclosed by a boundary line drawn as follows: beginning at Fish Point at the easterly end of Portland, thence extending about northerly to Pomeroy's Rock to Half Way Rock southerly of Mackworth Island and to the easterly point of the outer of the Twin Brothers' Islands, thence about northwesterly and westerly along the shores of said last mentioned islands, the shore of the Town of Falmouth, the southerly side of Martin's Point bridge, the shores of the United States Marine Hospital, and East Deering, and the southerly side of Tukey's bridge to the shore at the northerly end of the Eastern Promenade, thence about southeasterly along the shore of the Eastern Promenade to the point begun at,' so that the said section shall read as follows:

'Sect. 85. Back Bay, Portland, 1917, C. 219, 78. No person shall at any time hunt, chase, catch, kill or destroy any water fowl or any other wild hird in Back Bay, so-called, in Portland, in the county of Cumberland, above the Grand Trunk

Railway bridge or within the area enclosed by a boundary line drawn as follows: beginning at Fish Point at the easterly end of Portland, thence extending about northerly to Pomerov's Rock, to Half Way Rock (southerly of Mackworth Island) and to the easterly point of the outer of the Twin Brothers' Islands, thence about northwesterly and westerly along the shores of said last mentioned islands, the shore of the Town of Falmouth, the southerly side of Martin's Point bridge, the shores of the United States Marine Hospital, East Deering, and the southerly side of Tukey's bridge to the shore at the northerly end of the Eastern Promenade, thence about southeasterly along the shore of the Eastern Promenade to the point begun at. No person shall have in possession at any time any water fowl or any other wild bird or any wild animal, or part thereof, taken in violation of any provision of this section. Whoever violates any provision of this section shall be punished by a fine of not less than ten dollars, nor more than forty dollars and costs, for each oilfense.'
