STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND THIRTY-ONE

AN ACT to Appropriate Moneys for the Expenditures of the Government and for Other Purposes for the Years July First, Nineteen Hundred and Thirty-one to June Thirtieth, Nineteen Hundred and Thirty-two and from July First, Nineteen Hundred and Thirty-two to June Thirtieth, Nineteen Hundred and Thirty-three.

Be it enacted by the People of the State of Maine, as follows:

In order to provide for the necessary expenditures of government for the next two fiscal years from July first, nineteen hundred and thirty-one to June thirtieth, nineteen hundred and thirty-two and from July first, nineteen hundred and thirty-two to June thirtieth, nineteen hundred and thirty-three, the following sum as designated in the following tabulations, are hereby appropriated out of any moneys in the state treasury, and the governor, with the advice of his council, is hereby authorized at any time prior to July thirty-first, nineteen hundred and thirty-two and July thirty-first, nineteen hundred and thirty-three, to draw his warrant on the state treasurer for the same, and any bills presented after those dates may be paid, on recommendation of the auditor, from current appropriations; and be it further provided that the appropriation for the support of paupers and other dependent persons be deemed a carrying account for the next two years.
