STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND THIRTY-ONE

AN ACT Relating to Pauper Settlements.

Be it enacted by the People of the State of Maine, as follows:

Section three of chapter thirty-three of the revised statutes is hereby amended by striking out the whole of said section and substituting in place thereof the following:

‘Sec. 3. Settlements remain; living beyond limits of state causes loss of settlement. Settlements acquired under existing laws, remain until new ones are acquired or until lost under the provisions of this section. Former settlements are defeated by the acquisition of new ones. Whenever a person having a pauper settlement in a town, has lived, or shall live, for five consecutive years in any unincorporated place or places in the state, or five consecutive years outside of the town in which he has a settlement after August one, nineteen hundred twenty-six, without receiving pauper supplies from any source within the state, he and those who derive their settlement from him lose their settlement in such town, and whenever a person having a pauper settlement in any town in the state shall after April twenty-nine, eighteen hundred ninety-three, live for five consecutive years beyond the limits of the state without receiving pauper supplies from any source within the state, he and those who derive their settle-

ment from him lost their settlement in such town. A person in the military or naval service of the United States shall be deemed to be a resident of the town in which he was a resident at the time of his enlistment or induction.'
