IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND THIRTY-ONE

AN ACT to Amend the Charter of the Gray Water District.

Be it-enacted by the People of the State of Maine, as follows:

Section 1. Chapter thirty-three of the private and special laws of Maine of 1929, entitled "An Act to Create the Gray Water District," is hereby amended by adding thereto the following section:

'Sec. 18. From and after January 1, 1932, whenever the term of office of a trustee of said Gray Water District expires, his successor shall be elected for a term of five years, as provided by section nine of said act, at a special election of the voters of said district, to be called and held, however, on the same day as the annual town meeting rather than on the first Monday of May, as now provided by said section nine, and the term of office of the trustee which under the present wording of said section, would have expired on the first Monday of May, 1932, shall expire on the date of the said annual town meeting in 1932, and his successor shall be elected to hold office for a term of five years from the date of said town meeting. The result of all elections for such trustees shall be declared by the moderator presiding at said meetings, and recorded by the town clerk upon his records, and due certificate of such election shall be filed by the town clerk with the trustees of

said district, and it shall be the duty of said trustees to see that such certificate is duly entered upon the records of said district and such certificate so recorded shall be sufficient evidence in all cases of the legality of such elections.'

Sec. 2. All provisions of said chapter thirty-three inconsistent herewith are hereby repealed.
