RESOLVE, Providing pensions for certain soldiers and dependents of soldiers.

---

Resolved: That a Pension is hereby granted to each of the persons hereinafter listed in the amount set against their name, to be paid quarterly from the funds for pensions for soldiers and their dependents. Said pensions shall begin on July first, nineteen hundred and thirty-one, and shall continue until otherwise provided by the Legislature.

Provided, however, that in all cases where the applicants are now receiving a State Pension, the amount named herein shall be in lieu thereof and not in addition thereto.
