RESOLVE, Relative to Fishing in Certain Somerset County Waters.

Fishing in certain Somerset county waters, regulated. Resolved: That the commissioner of inland fisheries and game is hereby directed to issue a rule and regulation establishing a daily bag limit of 10 fish and of not more than 5 pounds per person per day, from any or all waters located in the later named towns, and that no trout less than 7 inches in length shall be taken from any or all waters located in the following named towns: Misery town, Parlin Pond town, Ten Thousand Acre Tract, Johnson Mountain town, Upper and Lower Enchanted, Pleasant Ridge plantation; and to issue further rules and regulations as follows:

In Misery town, Misery stream is closed to fishing for its entire length; Cold Stream pond, partly in Misery town, Johnson Mountain town and Parlin Pond town shall be open to bait or fly fishing from the time the ice goes out until June 1st; fly fishing only after June 1st;

In Ten Thousand Acre Tract all waters shall be open to fly fishing only with the following exceptions (Ireland pond, Acre pond, Ten Thousand Acre pond, Little Chase Stream pond, Chase Stream pond, Little Chase Stream, Mud pond, all in Ten Thousand Acre Tract and Knights pond partly in Chase Stream town and Ten Thousand Acre Tract;

In Johnson Mountain town fly fishing only with the exception of the following waters which are closed to all fishing: East Branch of Cold stream, from Cold Stream pond to No. 6 dam and tributaries, West Branch of Cold Stream from Big Berry pond to No. 6 dam and tributaries. (These rules and regulations shall not apply to Parlin pond and tributaries and Youngs pond in Pleasant Ridge plantation.)

The waters of Alder pond which lies partly in Spencer Tract and T. 3, R. 5 in Upper and Lower Enchanted Twps., shall be included in these rules and regulations;

In Pleasant Ridge plantation, the waters of Wyman lake shall be open to fishing under the general law;

The waters of the Kennebec river from Moosehead dam to Wyman lake shall be open under the general law from May 1st to Sept. 15th; from Sept. 15th until Sept. 30th fly fishing only. From Wyman dam down to the Bingham town line it shall be open from the time the ice goes out until Sept. 15th under the general law and from Sept. 15th to Sept. 30th fly fishing only.
