STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED THIRTY-NINE

AN ACT Regulating the Operation of Motor Vehicles.

Be it enacted by the People of the State of Maine, as follows:

Sec. I. R. S., c. 29, § 5, amended. Section 5 of chapter 29 of the revised statutes is hereby amended to read as follows:

'Sec. 5. Vehicles shall keep to the right boundary of way. A person in control of any vehicle moving slowly along a way shall keep said vehicle as closely as practicable to the right-hand boundary of the way, allowing more swiftly moving vehicles reasonably free passage to the left. Any person operating a motor vehicle shall not pass or attempt to pass any motor vehicle proceeding in the same direction between points on a highway where temporary warning signs are placed indicating that persons are working on said highway.

Operators of motor vehicles approaching each other from opposite directions on the highway shall keep said motor vehicle to the right of the center line of the highway.

All motor vehicles shall be driven on the right-hand side of the highway at all times except on one-way streets or while passing other vehicles.

No person shall walk in any highway where there are sidewalks or paths provided for the use of pedestrians, and on highways where no such sidewalks or paths are provided, or are obstructed by snow or other obstructions pedestrians shall walk only on the extreme left side of the highway facing approaching traffic.

The driver of any motor vehicle being driven toward the highway from an alley, driveway or garage shall bring such vehicle to a complete stop immediately prior to driving upon the sidewalk or path at the edge of said highway, or if no such sidewalk or path immediately prior to driving into said highway.'

Sec. 2. R. S., c. 29, § 71, amended. Section 71 of chapter 29 of the revised statutes is hereby repealed and the following enacted in lieu thereof:

'Sec. 71. Overtaking vehicle not to pass another under certain conditions. The driver of a motor vehicle shall not overtake and pass another vehicle proceeding in the same direction, upon the crest of a grade or upon a curve in the way, where the driver's view along the way is obstructed within a distance of 500 feet. The driver of a vehicle shall not overtake and pass any other vehicle proceeding in the same direction at any steam or electric railway grade crossing nor at any intersection of ways, unless permitted so to do by a traffic or police officer.'

Sec. 3. R. S., c. 29, § 73, amended. Section 73 of chapter 29 of the revised statutes is hereby repealed and the following enacted in lieu there-of:

'Sec. 73. Vehicles shall travel reasonable distance apart. The driver of a motor vehicle shall not follow another vehicle more closely than is reasonable and prudent, having due regard to speed, traffic, and the condition of the highway. The driver of any motor bus, motor truck, or other commercial motor vehicle when traveling upon a way outside of a business or residence district, shall not follow another such vehicle within 300 feet, but this shall not be construed to prevent such motor vehicle overtaking and passing another.'

Sec. 4. R. S., c. 29, additional. Chapter 29 of the revised statutes is hereby amended by adding after section 79 thereof the following section to be numbered 79-A, to read as follows:

'Sec. 79-A. Clinging to or hitching to moving vehicles. No person shall cling to or ride on the outside or rear end of any vehicle and no person on a bicycle, roller skates, sled or similar device, shall hold fast to or hitch on to any moving vehicle.' Sec. 5. R. S., c. 29, § 82, amended. Section 82 of chapter 29 of the revised statutes is hereby amended by adding at the end thereof the following paragraph:

'Every bicycle when in use at night shall show a light visible in both directions with a white light to the front and a red light to the rear and also shall be equipped with an audible signal device.'

Sec. 6. R. S., c. 29, § 83, amended. Section 83 of chapter 29 of the revised statutes is hereby amended to read as follows:

'Sec. 83. Every vehicle to display lights; dimmers; certain exceptions. Every vehicle, whether stationary or in motion, on any way or bridge shall have attached to it a light or lights so displayed as to be visible from the front and rear thereof during the period from $\frac{1}{2}$ hour after sunset to $\frac{1}{2}$ hour before sunrise, and at all times during other hours of the day when the view on any highway is in any way obscured by fog, mist or rain; provided, however, that this section shall not apply to any vehicle which is designed to be propelled by hand, nor to any vehicle not in motion and parked or beside a curb in a place and under conditions where there is sufficient artificial light to make such vehicle clearly visible from a distance not less than 100 feet in each direction. Every motor vehicle shall be equipped so that the lights on the front thereof can be dimmed and drivers of such motor vehicles shall dim such headlights when approaching an-*i* other motor vehicle coming in the opposite direction on said highway.'
