**AN ACT Relating to Clerk Hire in Certain Counties.**

---

---

Be it enacted by the People of the State of Maine, as follows:

**Sec. 1. R. S., c. 125, § 46, amended.** The paragraphs of section 46 of chapter 125 of the revised statutes, as amended, insofar as they relate to Hancock county, Lincoln county, Somerset county and York county, are hereby further amended to read as follows:

‘Hancock county: for clerks in the office of register of deeds, \$1500; for clerks in the office of register of probate, ~~seven hundred eighty dollars~~ **\$1560**; for clerks in the office of clerk of courts, ~~seven hundred eighty dollars~~ **\$1092.**’

‘Lincoln county: for clerks in the office of register of deeds, \$800, **and such additional sum not exceeding \$300, when necessary, subject to the approval of the county commissioners**; for clerks in the office of register of probate, ~~one hundred sixty dollars~~ **\$285**; for clerks in the office of clerk of courts, ~~two hundred dollars~~ **\$325.**’

'Somerset county: for clerks in the office of register of deeds, \$1500; for clerks in the office of register of probate, ~~five hundred dollars~~ \$1000; for clerks in the office of clerk of courts, ~~ten hundred forty dollars~~ \$1540.'

York county: for clerks in the office of register of deeds, ~~three thousand dollars~~ \$4000; for clerks in the office of register of probate, \$2080; for clerks in the office of clerk of courts, \$1750.

(Provided, however, that the changes in the provisions for York county shall be effective for 2 years only from the effective date of this act.)'

**Sec. 2. R. S., c. 125, § 44, amended.** The 20th line of section 44 of chapter 125 of the revised statutes is hereby amended to read as follows:

'Washington, \$1350; for clerk hire, \$300.'
