**RESOLVE, Proposing an Amendment to the Constitution Abolishing the
Governor's Council.**

Resolved: Two-thirds of the legislature concurring, that the following amendment to the constitution of this state be proposed:

Article V, part second, of the constitution; relating to governor's council, repealed. Part second of Article V of the constitution is hereby repealed. Whenever in the constitution and its amendments the words "and council" or "council" or "governor's council" appear referring to the "governor's council" they shall be struck out, and be it further

Form of question and date when amendment shall be voted upon. Resolved: That the aldermen of cities, the selectmen of towns and the assessors of the several plantations of this state, are hereby empowered and directed to notify the inhabitants of their respective cities, towns and plantations to meet in the manner prescribed by law for calling and holding biennial meetings of said inhabitants for the election of senators and representatives, at the next state election following the passage of this resolve, to give in their votes upon the amendment proposed in the foregoing resolution, and the question shall be:

"Shall the constitution be amended as proposed by a resolution of the legislature providing for the abolishment of the governor's council?"

And the inhabitants of said cities, towns and plantations shall vote by ballot on said question; those in favor of the amendment voting "Yes" upon their ballots, and those opposed to the amendment voting "No" upon their ballots; and the ballots shall be received, sorted, counted and declared in open ward, town and plantation meetings, and return made to the office of the secretary of state in the same manner as votes for governor and members of the legislature, and the governor and council shall count the same, and if it shall appear that a majority of the inhabitants voting on the question are in favor of the amendment, the governor shall forthwith make known the fact by his proclamation, and the amendment shall on the 30th day of January next following the date of said election become a part of the constitution.

Secretary of state shall prepare ballots. Resolved: That the secretary of state shall prepare and furnish to the several cities, towns and plantations ballots and blank returns in conformity with the foregoing resolve accompanied by a copy thereof.
