## STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED FORTY-ONE

AN ACT to Re-establish the Town Line Between the Town of Glenburn and the City of Old Town.

Be it enacted by the People of the State of Maine, as follows:

- Sec. r. Town line between Glenburn and Old Town established. That part of the town of Glenburn situate eastward of Pushaw lake, bounded on the north by the town of Hudson, on the east by the city of Old Town, and on the west and south by Pushaw lake; being a triangular lot of land, containing about 100 acres is incorporated into and made a part of the city of Old Town.
- Sec. 2. Re-assessment of taxes. All taxes now legally assessed and remaining unpaid upon any of the land which by this act becomes a part of the city of Old Town shall be due and payable to the town of Glenburn, and the collector of taxes of Glenburn is hereby authorized and required to collect and pay over to his town all taxes that have been committed to him.
- Sec. 3. Pauper residence regulated. If any person who now resides in the portion of Glenburn herein incorporated into Old Town shall fall into distress or become a pauper after this act shall take effect, his legal status, for the purpose of establishing his pauper settlement shall be the same as

if he had removed from one town to the other and taken up his residence in the other town on the day this act shall take effect.

- **Sec. 4. Duties of city.** After the effective date of this act, the city of Old Town shall bear all expenses for the care and maintenance of all schools, roads and bridges within the herein incorporated district, as well as other municipal expenses.
- Sec. 5. Transfer of title to town property. All real estate, if any, including schoolhouse and lots, belonging to the town of Glenburn, which by this act shall be changed from within the boundaries of Glenburn to Old Town, shall be and become the property of Old Town without the payment of any compensation therefor.
- Sec. 6. Adjustment of valuation. Such sum as represents the valuation of the district hereby set off to the city of Old Town as shown by the assessor's books of the town of Glenburn for the year 1940 is hereby deducted from the valuation of the town of Glenburn, upon which state and county taxes are assessed, and added to the valuation of the city of Old Town.
