STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED
FORTY-ONE

AN ACT Relating to the Voting Precincts in the Town of Harpswell.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. P. & S. L., 1907, c. 40, §§ 1, 2, amended. Sections 1 and 2 of chapter 40 of the private and special laws of 1907, are hereby repealed and the following enacted in place thereof:

‘Sec. 1. Great Island precinct. The following islands, part of the town of Harpswell, in the county of Cumberland, namely: Sebascodegan, known as Great Island, also called East Harpswell, Dingley Island, Yarmouth Island, and other small adjacent islands hereby are created a voting precinct to be known as “Great Island Precinct,” for the election of representatives to the legislature, senators, county and state officers and electors of president and vice president.’

‘Sec. 2. Orr’s and Bailey island precinct. The following islands, part of said town of Harpswell, namely: Orr’s, Ragged and Bailey islands hereby are created a voting precinct to be known as the “Orr’s and Bailey Island Precinct,” and the officers thereof shall be subject to the laws relating to the election of the offices hereinbefore described, enacted in case of towns except as hereinafter expressly provided; the municipal officers of

said Harpswell 60 days before any election may, after public notice and hearing include within said Orr's and Bailey island precinct that part of Great island adjacent to Orr's island known as the "Gun point and Dyer's cove" sections.'

'Sec. 2-A. Mainland precinct. The remainder of said town of Harpswell, including the mainland, Birch island, upper and lower Goose islands, Little and Great Whaleboat islands, Haskell island and other adjacent islands, shall be known as the "mainland precinct" and the officers thereof shall be subject to the laws relating to the election of the officers described in the preceding section hereof enacted in case of towns.'

Sec. 2. Amending clause. Sections 3, 4, 5, and 6 of chapter 40 of the private and special laws of 1907 are hereby amended by striking out the words "island district" wherever found and inserting in place thereof the names 'Great island precinct' and 'Orr's and Bailey island precinct.'
