STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED FORTY-THREE

AN ACT Relating to Fees of the Clerks of the Judicial Courts.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 126, § 3, amended. Section 3 of chapter 126 of the revised statutes is hereby repealed and the following enacted in place thereof:

'Sec. 3. Clerks of the courts. The fees of clerks of the judicial courts shall be as follows:

For every blank writ of attachment with a summons, or of scire facias or an original summons, 10c.

Blank writs or replevin with the seal, signature and blank bond, 15c.

Entry of an action entering up and recording the judgment whether on a verdict, demurrer, non-suit or default, \$1.

Copies, minimum of \$1 for first 500 words, if the writing contains that number, and 25c per hundred words or fraction thereof in excess of 500 words.

Recording a petition and proceedings for release of attachment and making copy and certificate, \$2.

Making certificate of dissolution of attachment by judgment for defendant, 50c.

Making a certificate of approval by judge, of sale of real estate and price,

when husband or wife refuses to release interest and right by descent, \$1. Authenticating the official signature of a magistrate, 50c.

Original or other writ of execution in personal matters, and filing the same when returned, 50c; same in a lien case, \$1.

Writ of possession in real action, \$1.

Writ of protection or habeas corpus, \$1.

Abstract of writ of possession on conditional judgment, and certificate, \$1.

Subpoena for one witness or more, or with a duces tecum, 10c.

Blank libel for divorce and copy, 20c.

Recording certificate of discharge of a soldier or seaman from the army or navy of the United States, 50c, and for a copy of such record, 50c.

Recording certificate of registration in optometry, or veterinary surgery, \$1.

For making up a record in an equity case \$1 for the first 500 words, if the record contains that number, and 25c per hundred words or fraction thereof in excess of 500, the same to be taxed in the bill of costs.

For each certificate, or copy of judgment or decree, in equity, \$1, which, together with the fees of the register of deeds for recording such certificate or copy, may be taxed in the costs of suit.

Writ of review, \$1.50.

Writ of scire facias, \$1.

Every writ and seal, other than before mentioned, \$1.

Certified copies of docket entries, 50c.

Copies of indictment and record for use in pardon cases, \$2.

Order of notice on a writ, libel or petition, 50c.

Computing damages and taxing costs, \$1.

Certified copy of decree of divorce, or a certificate, \$2.

Recording deputy sheriffs' commissions, 25c each.

Recording a petition for partition, and any order thereon, at the rate of 25c a page of 224 words.
