#### STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED FORTY-FIVE

RESOLVE, for Maintenance and Development of Public Park Facilities.

Maintenance and development of public park facilities. Resolved: That there be, and hereby is, appropriated the sum of \$554,888 for the biennium ending June 30, 1947, for the maintenance and development of public park facilities, to be expended by and under the supervision of the Maine state park commission.

This appropriation shall be expended for the maintenance and development of each park and memorial as listed below, for the purposes enumerated under their names in the amounts set forth opposite each item:

#### STATEMENT OF FACTS

This appropriation is necessary to provide additional facilities where present facilities are inadequate or overcrowded; to replace equipment no longer serviceable; to carry out reforestation; enlarge parking and road facilities; rehabilitate walls and roof of Fort Knox; to acquire and develop a public seashore recreational area; and to create year around public recreational opportunities in Aroostook County State Park.
