STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED
FORTY-FIVE

AN ACT Relating to the Salary of Various Officers of Waldo County.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 79, § 114, amended. That part of section 114 of chapter 79 of the revised statutes which relates to Waldo county is hereby amended to read as follows:

'Waldo, ~~\$1,400~~ \$1,800.'

Sec. 2. R. S., c. 79, § 130, amended. That part of section 130 of chapter 79 of the revised statutes which relates to Waldo county is hereby amended to read as follows:

'Waldo, ~~\$1,000~~ \$1,300.'

Sec. 3. R. S., c. 79, § 146, amended. That part of section 146 of chapter 79 of the revised statutes which relates to Waldo county is hereby amended to read as follows:

'Waldo, ~~\$400~~ \$600.'

Sec. 4. R. S., c. 79, § 151, amended. Section 151 of chapter 79 of the revised statutes is hereby amended to read as follows:

'Sec. 151. Payments to county law libraries. The treasurer of each county, except the counties of Androscoggin, Aroostook, Cumberland,

Franklin, Hancock, Kennebec, Knox, Lincoln, Penobscot, Somerset, Washington, **Waldo** and York shall pay annually to the treasurer of the law library association of his county, for the uses and benefits of the county law library, the sum of \$500. The treasurers of each of the following counties shall pay annually to the treasurer of the law library association of his county, for the uses and benefits of the county law library, as follows: Androscoggin, the sum of \$1,000; Aroostook, the sum of \$1,900, of which \$1,100 shall be for the use and benefit of the county law library in the court house at Houlton in said county and \$800 shall be for the use and benefit of the county law library in the court house at Caribou in said county; Cumberland, the sum of \$1,000; Franklin, the sum of \$750; Hancock, the sum of \$1,000; Kennebec, the sum of \$1,000; Knox, the sum of \$1,000; Lincoln, the sum of \$250; Penobscot, the sum of \$1,000; Somerset, the sum of \$750; Washington, the sum of \$900; **Waldo, the sum of \$350;** York, the sum of \$1,250.

The treasurer of each county shall also pay to the treasurer of the law library association of his county all money received from persons admitted upon motion to practice in courts of record as attorneys without a certificate from the board of examiners of applicants for admission to the bar.'

Sec. 5. R. S., c. 79, § 165, amended. That part of section 165 of chapter 79 of the revised statutes which relates to Waldo county is hereby amended to read as follows:

'Waldo, ~~\$1,500~~ \$1,800.'

Sec. 6. R. S., c. 79, § 231, amended. That part of section 231 of chapter 79 of the revised statutes which relates to Waldo county is hereby amended to read as follows:

'Waldo, ~~\$1,000~~ \$1,500.'

Sec. 7. R. S., c. 79, § 269, amended. That part of section 269 of chapter 79 of the revised statutes which relates to Waldo county is hereby amended to read as follows:

'Waldo county: for clerks in the office of register of deeds, ~~\$1,560~~ \$2,080; for clerks in the office of register of probate, ~~\$780~~ \$1,040; for clerks in the office of the clerk of courts, ~~\$800~~ \$1,040.'

Sec. 8. R. S., c. 140, § 3, amended. That part of section 3 of chapter 140 of the revised statutes which relates to Waldo county is hereby amended to read as follows:

'Waldo, ~~\$1,000~~ \$1,500.'

Sec. 9. R. S., c. 140, § 22, amended. Section 22 of chapter 140 of the revised statutes which relates to Waldo county is hereby amended to read as follows:

'Waldo, ~~\$1,200~~ \$1,500.'

Sec. 10. Effective date. The provisions of sections 1 to 9, inclusive, shall be effective from January 1, 1945.
