#### STATE OF MAINE

# IN THE YEAR OF OUR LORD NINETEEN HUNDRED FORTY-FIVE

#### AN ACT to Increase Salaries of Somerset County Officers.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 79, § 6, amended. That part of section 6 of chapter 79 of the revised statutes which relates to the salary of the county commissioners of Somerset county is hereby amended to read as follows:

'Somerset, \$650 \$800,'

Sec. 2. R. S., c. 79, § 114, amended. That part of section 114 of chapter 79 of the revised statutes which relates to the salary of the clerk of courts of Somerset county is hereby amended to read as follows:

'Somerset, \$2,500 \$3,000,'

Sec. 3. R. S., c. 79, § 130, amended. That part of section 130 of chapter 79 of the revised statutes which relates to the salary of the county attorney of Somerset county is hereby amended to read as follows:

'Somerset, \$1,200 \$1,500,'

Sec. 4. R. S., c. 79, § 146, amended. That part of section 146 of chapter 79 of the revised statutes which relates to the salary of the county treasurer of Somerset county is hereby amended to read as follows:

'Somerset, \$800 \$900,'

Sec. 5. R. S., c. 79, § 165, amended. That part of section 165 of chapter 79 of the revised statutes which relates to the salary of sheriff of Somerset county is hereby amended to read as follows:

'Somerset, \$4,600 \$2,000,'

Sec. 6. R. S., c. 79, § 231, amended. That part of section 231 of chapter 79 of the revised statutes which relates to the salary of the register of deeds of Somerset county is hereby amended to read as follows:

'Somerset, \$1,800 \$2,100,'

Sec. 7. R. S., c. 79, § 269, amended. The 14th paragraph of section 269 of chapter 79 of the revised statutes is hereby amended to read as follows:

'Somerset county: for clerks in the office of register of deeds, \$2,000 \$3,600; for clerks in the office of register of probate, \$1,000 \$1,300; for clerks in the office of clerk of courts, \$7,540 \$1,800.'

Sec. 8. R. S., c. 140, § 3, amended. That part of section 3 of chapter 140 of the revised statutes which relates to the salary of the judge of probate of Somerset county is hereby amended to read as follows:

'Somerset, \$1,500 \$2,000,'

Sec. 9. R. S., c. 140, § 22, amended. That part of section 22 of chapter 140 of the revised statutes which relates to the salary of the register of probate of Somerset county is hereby amended to read as follows:

'Somerset, \$7,800 \$2,000,'
