STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED
FORTY-FIVE

AN ACT Relating to the Salaries of Various Officers of Franklin County.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 79, § 130, amended. That part of section 130 of chapter 79 of the revised statutes which relates to Franklin county is hereby amended to read as follows:

'Franklin, ~~\$750~~ \$950.'

Sec. 2. R. S., c. 79, § 146, amended. That part of section 146 of chapter 79 of the revised statutes which relates to Franklin county is hereby amended to read as follows:

'Franklin, ~~\$500~~ \$800.'

Sec. 3. R. S., c. 79, § 165, amended. That part of section 165 of chapter 79 of the revised statutes which relates to Franklin county is hereby amended to read as follows:

'Franklin, ~~\$1,200~~ \$1,600.'

Sec. 4. R. S., c. 79, § 231, amended. That part of section 231 of chapter 79 of the revised statutes which relates to Franklin county is hereby amended to read as follows:

'Franklin, ~~\$1,300~~ \$1,500.'

Sec. 5. R. S., c. 79, § 269, amended. The 5th paragraph of section 269 of chapter 79 of the revised statutes is hereby amended to read as follows:

'Franklin county: For clerks in the office of register of deeds, ~~\$780~~ \$880; for clerks in the office of register of probate, ~~\$400~~ \$500; for clerks in the office of the clerk of courts, ~~\$780~~ \$1,300.'

Sec. 6. R. S., c. 140, § 22, amended. That part of the 2nd paragraph of section 22 of chapter 140 of the revised statutes which relates to Franklin county is hereby amended to read as follows:

'Franklin, ~~\$1,050~~ \$1,250.'

Sec. 7. R. S., c. 140, § 3, amended. That part of the 2nd paragraph of section 3 of chapter 140 of the revised statutes which relates to Franklin county is hereby amended to read as follows:

'Franklin, ~~\$600~~ \$900.'
