STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED FORTY-FIVE

AN ACT Amending the Unemployment Compensation Law as to Benefits.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 24, § 3, ¶ (c) amended. Subsection (c) of section 3 of chapter 24 of the revised statutes is hereby amended to read as follows:

'(c) Weekly benefit for partial unemployment. On and after April 1, 1945, each Each eligible individual who is partially unemployed and who has earned less than his weekly benefit amount in any week shall be paid with respect to such week a partial benefit. Such partial benefit shall be the individual's weekly benefit amount reduced by the amount shown in column (C) in the schedule below on the line on which in column (A) there is indicated the individual's weekly earning class. The individual's weekly earning class shall be determined by the wages payable paid to him for employment during the week for which he claims a partial benefit as shown in column (B).
