STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED
FORTY-FIVE

AN ACT to Increase the Salaries of Certain Oxford County Officials.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 79, § 6, amended. That part of section 6 of chapter 79 of the revised statutes which relates to the salaries of the county commissioners of Oxford county is hereby amended to read as follows:

'Oxford, ~~\$700~~ \$900.'

Sec. 2. R. S., c. 79, § 114, amended. That part of section 114 of chapter 79 of the revised statutes which relates to the salary of clerk of courts of Oxford county is hereby amended to read as follows:

'Oxford, ~~\$2,100~~ \$2,300.'

Sec. 3. R. S., c. 79, § 146, amended. That part of section 146 of chapter 79 of the revised statutes which relates to the salary of the county treasurer of Oxford county is hereby amended to read as follows:

'Oxford, ~~\$1,200~~ \$1,450.'

Sec. 4. R. S., c. 79, § 231, amended. That part of section 231 of chapter 79 of the revised statutes which relates to the salary of the registers of deeds of Oxford county is hereby amended to read as follows:

'Oxford, eastern registry, ~~\$1,500~~ \$1,800; western registry, ~~\$1,000~~ \$1,300.'

Sec. 5. R. S., c. 140, § 3, amended. That part of section 3 of chapter 140 of the revised statutes which relates to the salary of the judge of probate of Oxford county is hereby amended to read as follows:

'Oxford, ~~\$1,500~~ \$1,800.'

Sec. 6. R. S., c. 140, § 22, amended. That part of section 22 of chapter 140 of the revised statutes which relates to the salary of the register of probate of Oxford county is hereby amended to read as follows:

'Oxford, ~~\$1,800~~ \$2,150.'
